For many years, some people both internationally and in the United States have claimed that the People's War in Peru has failed since the detention of Dr. Abimael Gúzman (Chairman Gonzalo) in 1992. This claim is far from true: even to this day, revolutionaries in Peru have never stopped fighting for a minute for the happiness and freedom of the people.

However, for a lot of progressive-minded people, it could be very hard to find out more about the revolution in Peru. The amount of disinformation and slander by imperialism, revisionism and Peruvian reactionaries play a big role in this; at the same time, some self-proclaimed Maoist news sources also refuse to publish any news regarding the struggle in Peru and try to justify it with a variety of excuses.

With these things in mind, we have decided to compile three important documents by the Association New Democracy, Germany, an organ of the Peru People's Movement (MPP), generated organism of the Communist Party of Peru (CPP) for the work abroad. These documents gave an overview of the state of the CPP and the Peruvian revolution between the detention of Dr. Gúzman and the early 2010s, as well as highlighting the task of **General Reorganization of the Party** facing Peruvian revolutionaries today. We hope this book will be of help to the honest reader who seeks to learn more about the ongoing National Democratic Revolution in Peru.

[...] More than anything we base ourselves on the necessity of the People's War, its process and its lessons that only through People's War can one conquer and defend the new power; that needs to become a reality in the oppressed nations, in the imperialist countries and also for crushing restoration, in the end it always with us, in all types of revolutions: for the democratic, the socialist and the cultural revolutions and to enter our final goal, Communism. We have given the pledge not to lay down our arms until Communism. We reaffirm ourselves that war is the continuation of politics with other means, that it follows politics, that it has class character, that the People's War is the response to the World War.

We express our firm and unconditional greeting and subjection to Chairman Gonzalo, Great Leader of the Party and the revolution, the greatest living Marxist-Leninist-Maoist on the face of the Earth, continuator of Marx, Lenin and Chairman Mao, the Center of Party Unity and guarantee of triumph until Communism; to our all-powerful ideology, Marxism-Leninism-Maoism, Gonzalo Thought, mainly Gonzalo Thought, all-powerful because it is true; to the heroic combatant that leads the revolution, the Communist Party of Peru (CPP), especially on the occasion of the 83<sup>rd</sup> anniversary of its foundation; to the principles that the command never dies, that once the flag has been hoisted it can never be lowered, and People's War until Communism; to the 1<sup>st</sup> Congress of the Party, a Marxist Congress, a Marxist-Leninist-Maoist, Gonzalo Thought, mainly Gonzalo Thought Congress, that gave us our Basis of Party Unity (BPU) with its three elements, the ideology, Marxism-Leninism-Maoism, Gonzalo Thought, mainly Gonzalo Thought, the Programme and the General Political Line (GPL) with its center: the Military Line, to the 3<sup>rd</sup> Plenum of the Central Committee, a glorious Plenum, historic and transcendental, and the Speech of Chairman Gonzalo of the 24<sup>th</sup> of September 1992, and we are celebrating its 19<sup>th</sup> anniversary, that shines victoriously and powerfully before the world as a weapon of combat. Our fervent greeting to the Committees of the Party, to the Communist leaders, cadres and militants, to the combatants of the People's Liberation Army (PLA) and to the masses of the New Power, as well as the proletariat and the people of Peru as a whole, who are defending the principles of the Party and the revolution, who keep the flag of People's War high against the concentrated attack of imperialism, reaction and revisionism.

We reaffirm that revolution is the main historic and political trend and that it is more so every day; in serving the development of the New Great Wave of the Proletarian World Revolution. We salute the international proletariat, the peoples of the world and the International Communist Movement (ICM) and, within it, the Parties and Organizations of the Revolutionary Internationalist Movement (RIM), and brand with fire the new revisionism of Avakian and Prachanda that have tried to liquidate the RIM with the desire to sweep away every advance.

We express our concentrated class hatred against the miserable rats of the Right-Opportunist Line (ROL), revisionist and capitulationist, that



puts forward the plump reactionary hoax of the ‘Peace Accords’; miserable rats who unconditionally work for the Yankee CIA, the ROL upheld and nurtured by the reactionary armed forces. Miserable rats that openly negate the Great Leadership of Chairman Gonzalo and Gonzalo Thought and without shame say that they are following it and defend it. We also dismiss, reject, repudiate and mark with fire and profound class hatred the miserable rat who was José, his brood and cronies, and all those who conspire with him, as part of the plan of imperialism within its strategy of ‘low-intensity warfare’. To crush the People’s War they hoist another ROL, also revisionist and capitulationist. Miserable rats that completely negate Marxism, they start attacking Chairman Gonzalo and Gonzalo Thought and repeat word for word all the attacks of the reaction to negate Maoism, and then negating Lenin and also Marx. We crush this ulcer of renegades, miserable traitors, who have been working in the fulfillment of this black plan of imperialism, acting in a brown-nosing way like true agents of revisionism within our ranks.

We reaffirm, very especially, in our pledge to give our lives to defend our Great Leadership, Chairman Gonzalo, against any attack, wherever it comes from, and to serve the Peruvian Revolution as part of and in service of the Proletarian World Revolution.

### **ON THE PEOPLE’S WAR AND THE SITUATION OF THE TWO-LINE STRUGGLE IN THE PARTY**

Taking as a starting point the renewal of our pledge and our reaffirmation in all said above, it is necessary to specify the situation which we are in, a complex and difficult situation, because imperialism, through its agents in the country and abroad, have generated such an amount of confusion and lack of understanding on the international level of the true situation of our Party and the People’s War in Peru. Hence, it is necessary to unmask the true entrails of the other opportunist line that is presenting itself openly and wildly attacking our Great Leadership, Chairman Gonzalo, Gonzalo Thought, the Party and the People’s War. It is thus false that there is ‘*a new ,Left’-Opportunist Line*’ (LOL), it is not the truth of the class but represents the work of revisionism itself. What exists is another ROL, revisionist and capitulationist; the 3<sup>rd</sup> ROL, since the one that opposed the initiation of the People’s War. A 3<sup>rd</sup> ROL that has structured itself within the Party over years, in the Central Committee itself, and that have usurped, among other apparatuses, the Main Regional Committee (MRC) of the Party, the greater part of the PLA and have liquidated the main Support Bases. The head of the 3<sup>rd</sup> ROL is the one who used to be José and its body is mainly in the MRC.

These rats present themselves as *'armed to the teeth'* but they are only a **'handful of dust'**, like it is established: **'They have gone too far and when the right crosses the line, the masses start to react and they don't permit getting fooled again. The world neither is quiet nor in peace, the winds are blowing and the storms are rising in favor of the World Revolution.'** (Summary of the 1<sup>st</sup> Congress, 1989). Those who says that this line is 'new' want to fool the international proletariat and try to throw dust in the eyes of the Communists and revolutionaries of Peru, so that they don't assume the pending task. In Peru, since 2009, there isn't anyone that doesn't know about this line and anyone who is linked to the apparatuses of the Party has already known since long before. Since 2006 the monstrosities of this ROL, signed 'PCP M-L-M', have circulated, since 2003 we have continuous reports of the *'change in the discourse of the Shining Path in the Valley of the Rivers of Apurimac and Ene'* (VRAE) and even, much earlier, in December of 1999, the newspaper 'Clarín' of Buenos Aires, reported that *'the Shining Path goes into the villages and self-criticize for the faults committed under the leadership of ,Gonzalo''*. And so that no one gets surprised, the illustrated document that the crony abroad of José presents is from the book of the genocidal brigadier general Eduardo Fournier (',Feliciano': Captura de un senderista rojo', NRC Corporacion Grafica S.A.C., Lima, Peru, August 2003). So, for more than a decade he knew who they were and what their history is, so he can't act surprised to cover up his counter-revolutionary action.

Only by recognizing the real situation that the Party faces, with the truth of the class, just like it is, armed with our ideology, Marxism-Leninism-Maoism, Gonzalo Thought, mainly Gonzalo Thought, can we handle the pending task to overcome the bend, which is: reorganize the Party as part of the development of the People's War to conquer Power in the whole country. To reorganize the Party demands bold struggle against revisionism, blow up this ROL with People's War like what was done with the previous one; we have experience in how to deal with similar situations. We Communists fear nothing and nothing can break our firm conviction in the justness of our cause and its inevitable triumph. We leave those who lack the ideological strength, those who do not trust our all-powerful ideology, who don't trust the Party and the masses, to fall into despair. The confusion serves imperialism; it serves to sow doubt and suits those who want to spread pessimism. The light, the clarity serves the advancement of the revolution, serves to develop the People's War. Chairman Mao tells us: **'The truth serves the people.'**

## THE RIGHT-OPPORTUNIST LINE OF THE RAT JOSÉ WITH HIS BROOD AND OTHER CRONIES

It is necessary to see what the ROL of José and his cronies puts forward accurately to be able to demolish and sweep away all the convergences with this ROL. Its content is feudal-imperialist, it is against the Great Leadership of Chairman Gonzalo, it is against Marxism-Leninism-Maoism, Gonzalo Thought, it is against the Party and against the People's War. They aspire to bring forward the Four Changes: change in leadership, denying that the Center of Party Unity is our Great Leadership; putting forward the Central Committee as a supposed Center of Party Unity, negating what was put forward in the 1<sup>st</sup> Congress about the role of Chairman Gonzalo, instead of a proletarian leadership they try to impose a leadership of warlords; change in line, negating the GPL and its center the proletarian Military Line, they want to impose their revisionist *'new programme'* and their bourgeois military line, negating the CPP as a Marxist-Leninist-Maoist, Gonzalo Thought militarized Party — trying to impose their *'Militarized Party'* which is nothing more than a variant of the miscarriage of a 'political-military organization' of the rats of the Túpac Amaru Revolutionary Movement (MRTA), and; they want to change the People's War into a mercenary struggle in the service of the highest bidder.

On the ideological level José and his brood don't do anything more than repeat what comes from the bourgeoisie in their attacks on Marxism, they don't 'contribute' anything new. They attack Gonzalo Thought as *'dogmatic'*, *'sectarian'*, *'ultra-leftist'* like revisionists of all kinds have done since even before the initiation of the People's War. They put themselves also, in tune with their bastard father, the agent of Yankee-CIA, Gustavo Gorriti and the hoaxes of the Commission of Truth and Reconciliation (CVR), trying to blame the Party for the genocide committed by Yankee-imperialism and the old landowner-bureaucratic State against our people and the Party. But against Marxism they are impotent, because it's the scientific ideology of the last and most advanced class in history, the proletariat, and, because of this, they resort to put adjectives, they say whatever but can't sustain it. Instead of the creative application of Marxism-Leninism-Maoism, mainly Maoism on the specific conditions of the Peruvian Revolution, Gonzalo Thought, they put forward a caricature of Maoism, which shows that they have betrayed the class position, method and world outlook of the proletariat. It is enough to see their vomit about *'super-imperialism'*, *'colony and at the same time semi-colony'*, etc. until its most absurd expression in

their proposal for a new '*general Programme*', to prove that these militarists do not even manage the basics of Marxism. As victims of their own reactionary prejudices, of their feudal-imperialist ideology, they even reject the necessity of explaining their own rubbish. They adhere to the new revisionism, but they can't even repeat well what their masters are dictating. They seem more like vulgar cops than alleged Communists.

On the political level José and his brood of rats negate the GPL and its center, the Military Line, the Programme and all that is established in the plans of the Party, they go completely against the 4<sup>th</sup> Strategic Plan of Development of the People's War for the Conquest of Power and the 6<sup>th</sup> Military Plan for Constructing the Conquest of Power – plans approved by the 3<sup>rd</sup> Plenum of the Central Committee and within these the latest plan of the Central Committee is established: 'Unite the People Against the Fascist, Genocidal and Country-selling dictatorship!' of 1998, a plan that was not fulfilled, exactly because of the sabotage of these miserables in conspiracy with the reaction. They negate the Concrete Programme ('the three for and three against') that was established by the Party, instead they put forward 'alliance' with the 'incorrigible anti-Communist' politics in favor of the bureaucratic bourgeoisie and the landlords, they practice such an '*alliance*' with the power of the gamonals against the peasants, mainly the poor. They don't destroy the local power of the old, landlord-bureaucratic in service of imperialism, State, instead they, in their own words, work with the district and provincial authorities. What does this mean? It means that they take part in the apparatus of the old State through these '*democratic*' authorities, to drag the masses behind the 'good representatives'. That is parliamentary cretinism in a shameful manner, but like all the revisionists they believe the reactionary fairytale that: the '*mayors are good because they are directly elected by the people*'.

These rats are against Maoism, they are against the destruction of the local power of the enemy and the building of new power on its rubble. Because of this, for them, the People's War is 'genocide' and 'terrorism'. This is right-opportunism and not 'left', like some say. Those who say that these are 'left'-opportunists do it because they like this form, this 'soft' form of parliamentary cretinism more; more than the open and revealed form of the other rats (Miriam, Morote, Cox) of the 2<sup>nd</sup> ROL, that belongs to MOVADEF. Why? Because, like all revisionists, they put themselves in line with the principle of Mussolini: 'All through the State (bourgeois, our note), nothing against the State'. This means concretely: '*armed struggle*' for a feudal domain of one's own within the old State; landlord-bureaucratic State

which becomes more and more reactionary, with feudalization of the country and absolute concentration of power, as an expression of its last and definitive crisis, behind which is the reactionary armed forces under the command of imperialism, based on a hierarchy of authorities and regional and local bosses. These revisionist and capitulationist rats want to be part of this process. To be recognized as an *'actual power'* with their own armed forces and as representatives of this landlord-bureaucratic power submitted to imperialism in the region 'VRAE'. If we see things this way, we can't separate the process that these rats are going to follow until they lay in their black graves, from the general process of the collapse of the old State, that will be completely and thoroughly destroyed by People's War. This is the particular form of integration of this ROL in the process that the old State has been in since 1980, it is in this way that they specify their revisionist nature, in the style of the revisionist Teng; just like the traitors of the 2<sup>nd</sup> ROL, who are demonstrating their revisionism by saying that they are following Chairman Gonzalo while they are negating his Great Leadership and his Thought. They are trying to integrate themselves in the old State through amnesty and elections, in this way their parliamentary cretinism express itself. But when it comes to class nature, both ROLs serves the same cause. They are only rats of different broods of imperialism. Therefore, the struggle of the rat José, his gang and cronies is a mercenary struggle of the 'warlords' for the highest bidder. Later these also will be for recognition, for 'dialogue', for 'peace accords', and who is behind all this? Yankee-imperialism.

We continue with the head, José, and his brood, they deny that the main contradiction in the People's War remains being masses ↔ feudalism, they take the increasing Yankee intervention as a pretext to justify their *'People's War of national resistance'*, thereby they have 'an excuse' for not fighting against feudalism and for not to implementing the policy of 'land to the tiller'. They apply 'struggle for daily demands ism' (armed revisionism) that in the countryside means nothing else than to defend the interests of rich peasants and in the cities it is the same old reformist politics of the worker sell-outs. Not only that, but they also publicly assume the defense of those who *'make the drug'*. So they stand for keeping the peasantry under control and under the authority of the landlords and the big bourgeoisie, who are the ones that in this will maintain the control of the sowing, harvesting and production of the drug; so they recognize the *de facto* sovereignty of the landlords and the big bourgeoisie — and consequently also political sovereignty — over the land. They want to fool people that the drug production is a business of small farmers and not a large-scale production of the big

bourgeoisie and landlords, who make the peasantry work under semi-feudal conditions and produce mainly for imperialist markets. In this way, it is more convenient and tasty for these revisionist rats to put forward their capitulation in front of the domestic reaction and its imperialist master, with which they have contradictions of second order, speaking clearly, according to their interests, express themselves like this: if you do not intervene *‘to eradicate’* etc., *‘great’*, *‘everything is in order under the heavens’* and so let us *‘live in peace’*. This is a foreman dreaming of an understanding master.

From the above, their opposition to the Party’s Military Line is obvious. It could not be otherwise, being what they are, capitulationist and revisionist renegades, since the Military Line is the center of the GPL. Hence it is in regard to it that they express more clearly their revisionist line, specifically, they deny the core of the People’s War, the support base, with their *‘Mobile People’s Committees’* which are nothing else than *‘roaming gangs’* which has nothing to do with the fluid character of the new power, but they make permanent what is a temporary mode (displacements), that is why there are not any Open People’s Committees anymore. They deny the Unified People’s War, the necessity to unfold the People’s War in the cities as a complement, and they are fiercely opposed to the correct policy for the period that is **‘developing a gradual advance seeking to weld the People’s War with the class struggle of the proletariat and the people’s masses in the neighborhoods and shantytowns, at all times handling the two hills and laying the foundations of the insurrection’** (The Plan: *‘Overcome the Bend in the Road, Developing the People’s War!’*), here they express their opposition to the coming transfer of the center of gravity to the cities. In particular, they have expressed their total opposition to carry out actions in Lima, with its three characteristics of being capital, labor center and a big drum, which is essential to generate public opinion in favor of the People’s War, both at home and abroad. This is living proof of how deny the role of the proletariat as leading class in the revolution. This is how these militarist revisionists are following a bourgeois military line and are against the proletarian Military Line of the Party and Chairman Gonzalo.

In the two-line struggle they use dirty struggle, slandering and lies against Chairman Gonzalo and against those who defend his red line. They take administrative measures against the left. They vulgarize the two-line struggle to such an extent that instead of assuring that the left is imposed, only *‘diplomatic agreements’* between chieftains remain. Very noticeable is how they insist in the inner Party life, that what matters, in accordance with their bastard criteria, are posts; if one does not agree with the

*'systematization'* of the secretary / political commander / responsible according to the level, you are 'questioning the leadership' and are subjected to measures. So instead of organizing the two-line struggle, which corresponds to a Marxist-Leninist-Maoist, Gonzalo Thought understanding, they apply fascist methods. See how these misers, what they themselves admit, shouting about the necessity to 'defend the leadership', at the same time have put in system, what they did to usurp the responsibility from Feliciano — who then headed the Central Committee — their practice to hand over the left to the hands of reaction, just like the miserable traitor in Huallaga, the rat Julio. See how these issues were already being expressed in the Party in the mid-'90s: **'Take unjust measures for petty issues without being subjected to the principles nor the norms, a feudal criterion for personal power that is also expressed in a personal leadership and not one for the class, open violation of decisions, lying in front of criticism, underestimation of the role of women in the revolution, letting things pass, strife, insisting in errors and quarrels, wrong treatment or untimely treatment of problems, ,two-faced'-attitude, etc. [...]**' (Central Committee: 'Political Report', 1996). It is now clear that these misers, when they were crushed in the internal struggle, handed over Feliciano and other members of the leadership to usurp the Party.

The rats of the revisionist and capitulationist ROL of José and his brood, negates the Great Principle of Construction — on basis of the ideological and political simultaneously build up the organizational, in the midst of class and two-line struggle, everything within and serving the People's War for the conquest of power — and they apply a militarist approach. Regarding the Party they have tried to destroy the system of Committees of the Party, to impose a fascist structure of 'independent kingdoms' of chieftains, concretely that 'the guns control the Party'. About the PLA: They have liquidated the special detachments, detachments and militias in the city, in the countryside they have liquidated the local forces and base forces, transforming all into *'main forces'* — their *'roaming gangs'* — and in their actions an extreme conservatism is being expressed, reducing it to guerrilla combats, not carrying out the other four forms of actions, expressing a roaming militarism. Concerning the Front-New State they have liquidated the generated organizations, using the pretext that *'those who are for the Peace Agreement'* have *'usurped their names'* (while saying that *'the ROL has not taken even one Party apparatus'*), but in reality because of their opposition to the Mass Line of the Party, and mainly to its proletarian Military Line, they follow a bourgeois military line and they have liquidated the support bases to replace

them with their nefarious concept of *'Mobile People's Committees'*; fiercely they oppose the joint dictatorship and leave the gamonal power intact, in the cities they oppose the sixth form of new power, the People's Struggle Committees, saying that they were an expression of *'adventurism'*, and *'leftism'* and they don't construct power in the cities, they don't construct anything there.

This ROL, that the rat José heads, denies the role of leading class of the proletariat in the democratic revolution. Even when they speak of *'the broad people's masses'*, they talk about everyone (*'the bourgeoisie, the national bourgeoisie, merchants, transporters, builders, students, intellectuals, foreign industrialists that are being oppressed and constrained'*), but not mentioning the proletariat, they deny the worker-peasant alliance under the leadership of the proletariat as the constant body of the democratic revolution, and the poor peasantry as the main force of the revolution. In their texts they declare, what for many years has been their daily practice, a alliance with the landowners (*'medium and small'*), and they reach the extreme of putting forward *'we respect the big bourgeoisie and the feudal landowners that are pro-North American but do not fight against the revolution'*. These confessions by the miserable ones themselves show that they do not have a trace of proletarian vanguard, no trace of Communist Party which leads the People's War to realize the democratic revolution, instead they are a group that is militarist, a band of mercenaries. Its feudal-imperialist character is also very clearly expressed in its arch-reactionary conception of the role of women in the revolution, for these rats the female Comrades are second-class fighters, the servants of men and this conception they have tried to impose in a Party which had the highest percentage of female participation in history, the Party that generated the largest percentage of female leaders, cadres, Party members, combatants and masses of women in the history of the ICM, they wanted to impose this in the Party which generated Comrade Norah, the greatest heroine of the Party and the revolution, a great Communist leader and relentless anti-revisionist fighter.

José and his brood, have usurped the Central Committee of the Party, in which he has imposed himself as in charge by the force of guns. Close to him he has his staunch followers, chieftains, his near and dear ones, he is a disciple of Teng who absolutely negates Marxism, and absolutely negates Marxism-Leninism-Maoism, Gonzalo Thought. They have counted with the direct collaboration of the reaction to *'solve internal problems'*. They had the best servants, that sought to reconcile the irreconcilable, Marxism and revisionism, to go to Committee after Committee to take over the Party



apparatuses, and the ones they have not been able to take by assault, they have instead infiltrated with their positions, revisionist refinements, using the difficult situation in the Committees and their internal contradictions to plot intrigues and machinations. In all this they are counting with the aid of the reaction, just like the miserable traitor in Huallaga. Among these servants are their cronies. They apply bureaucratic methods, counterposing the organizational to the ideological and political in order to destroy the system of Committees and democratic centralism.

The seriousness of the situation in the two-line struggle has led to a situation where organizational problems have become absolutely subordinate; the main thing at this point in the struggle must be the ideological, because what is at stake is the color of the Party as a whole. Without unity of understanding, without unity of ideology, there is no BPU. It is more necessary than ever to grasp Gonzalo Thought to solve new problems.

We must see that there are other experiences in the history of the ICM, which gives us lessons to take into account. We do not share the way of those misers, like the main crony of the rat José abroad, in particular, to use the limitations that other Parties have, or may have, in the understanding of Maoism, and assume an inflated and arrogant attitude against the struggles of these Parties. This is an expression of empiricism, that one is only limited to one's own 'experience' and more, this reveals his true degustation, because such an attitude is an expression of chauvinism, corresponding to the 'nationalism' of the American People's Revolutionary Alliance (APRA), but which has nothing to do with a Communist attitude. In the case of India, we see how the Comrades at the start of the '80s were scattered in a large number of Factions, in several cases established on the basis of the various Regional Committees, and it took more than 20 years to achieve Party unity during a long and complex struggle, where there was a series of bloody incidents, capitulations and betrayals, but as they persisted in fighting for the unity without giving up arms, the Communists succeeded in establishing Party unity. On the Philippines, the Communist Party lost what was their main base (Mindanao), and passed through an internal process in which the revisionists killed over 1.000 Comrades, but carrying out a big rectification campaign, the Communists have managed to regain what was lost. The Turkish Comrades have lost a large number of leading members of the Central Committee, one after another, and the Maoist Communist Party (MKP) Comrades were also hardly stricken, losing not only the general secretary and the undersecretary, but most of their Central Committee as a whole, but at no time have they laid down their arms and they persisted in

the road of People's War. On the nefarious role of the conciliators, we have a very clear negative example in the case of Nepal, where the so-called left have secured the surrender and generated a lot of confusion among some detachments of the ICM. All these experiences should be taken into account to resolve the situation we now face. When crushing revisionism and capitulation, without ever giving up arms, we persists in developing People's War, placing the unity on the basis of the principles — in our case it should be repeated, Marxism-Leninism-Maoism, Gonzalo Thought, mainly Gonzalo Thought — in the forefront, then it is possible to overcome difficulties and take great leaps forward in the People's War.

### **THE DEFENSE OF THE PARTY APPARATUS FOR THE WORK ABROAD**

From the above stated, the development of the current situation of the Party, on national and international levels, in accordance with the fulfillment of our pledge to the class, it demands from those who assume this pledge in the Party work abroad, to assume the defense of the Peru People's Movement (PPM), crushing the ROL, revisionist and capitulationist, of the rat José, his brood and cronies — especially the counter-revolutionary agent who acts as a representative of a 'Central Committee' that does not exist in Peru — serving the urgent task of the general reorganization of the CPP as part of its task to lead victorious developments in the People's War to complete the democratic revolution, the conquest of power in the whole country in service of the Proletarian World Revolution and its everlasting goal, ever-golden Communism.

The reorganization of the Party is pending task set forth in the Plan 'Overcome the Bend in the Road, Developing the People's War!' of July 1995, that after the respective balance should have been developed further in the following plan of 1998: 'Unite the People Against the Fascist, Genocidal and Country-Selling Dictatorship, Developing the People's War Further!'. This task has not been materialized, because as we said, the two-line struggle within the Party escalated, because, with the help of the CIA and its lackeys, the Peruvian reaction, the 3<sup>rd</sup> ROL had the conditions for being structured within the Party, went on with the capture of the Party apparatus, first in the VRAE, and then to usurp the MRC and with this the Party leadership.

From the mouths of the treacherous rats themselves: José, Raúl and Alipio and their cronies, we know that on the 14<sup>th</sup> of July, 1999, they made a counter-revolutionary coup against the Party leadership, handing over of the head of the Party and other leaders of the Central Committee to the CIA

and the Armed Forces of the old genocidal State. Revisionism, with the help of the CIA and the Peruvian reaction, carried out this counter-revolutionary coup to decapitate the Party and, with this counter-revolutionary action, they usurped it. Then they split it up among them in feudal domains, specifically they divided the usurped Party apparatus between the rats of the two broods; VRAE and MRC for the rat José and his brood and the Huallaga Regional Committee for the rat Julio, who aligned himself with the brood of the other rats, Miriam, Morote, Pantoja, Cox, etc.

### **Who are the cronies of José?**

In the 3<sup>rd</sup> Plenum, Chairman Gonzalo treated very strenuously the question of the internal struggle, and he saw what was to come, the 2<sup>nd</sup> ROL, and, as it was up to him to do, he raised the concrete forms and methods to be applied to overcome the problem, and how to crush the revisionist positions. Very important in this is to manage the ‘Five Unities’ of Chairman Mao and the thesis of Stalin (that the base of everything is the line and on that follows the organization, etc.). It is therefore particularly necessary to remember what Chairman Gonzalo explained:

[...] Remember what Stalin said, unity is ‘the apple of our eye’; the one going against the unity goes against the Party, because at the end the Chairman has said, what are the unities? It is unity of understanding, unity of politics, unity of the plan, unity of command, unity of action, to act as Lenin said as a single fist. Was it not what he said? That is why you do not play with the unity. The Chairman, when he put forward the Five Unities, he talked about the Five Unities we need, first the unification of understanding, second unity in politics, third unity in plan, fourth unity in command, and fifth the unity in action; they are the Five Unities, five ways in which we unify to achieve unity and act like a single fist, the way that Lenin described it, so I repeat that this is ‘the apple of our eye’ and who does not understand what the apple of our eye is, right? It is something so expressive. Going against the unity is going against the very soul, against the Party, the problem is that this unity has an axis that is the ideological-political. (Report to the People’s Aid Committee.)

Thus, it is clear that those who aim against the unity of comprehension, who spread confusion, disagreements, hoaxes, and intrigues, serving directly the counter-revolutionary plan that seeks to blow up the Party. They are therefore the cronies of the enemy those who try to obscure the nature and process of the rats of the ROL of the treacherous José and his brood. Those who say that these rats are a ‘LOL’ should bear in mind the fact that

they have not presented a political report since 1999, nor a report on the new reactionary government of the fascist, genocidal and country-selling Humala, that was initiated by the Fujimori regime with his self-coup of April 5<sup>th</sup>, 1992. Rather than a serious report on the political situation and the current situation, they only make a few references to it in the passage, and do not go beyond what the reactionary media says about the first steps of the new government, so to pretend that they fulfilled their obligation. They make no ideological and political report, neither on construction, two-line struggle, its process, and therefore nor on the People's War or the struggle of the masses. Instead of making a Party report on the counter-revolutionary coup against the leadership of July 14<sup>th</sup>, 1999, they are presenting an illustrated report from the reaction, extracted from the book by former SIN general, Fournier, published in 2002. No Party report on Huallaga, no report on the rat Julio for more than 12 years. No report on our hill, or on the Shining Trenches of Combat, but instead a silencing of the heroic struggle of the prisoners of war. They don't do any political briefing about the defense of the Great Leadership, or what they are doing in respect to this task. Only, that you have to 'use any legal loophole to be able to listen to him', i.e. wait until the reaction has overlooked something. That crazy talk can only come from reactionary criteria trying to pretend that they are for his defense! Do we expect a more open confession that they do not belong to our hill?! To take one more example, about the nature and actual presence of this '*Central Committee*' and its 'imperial envoy', they do not present any reports of the struggle of the masses that they claim to lead, since they are not leading any. They present in their '*Party documents*', almost as in the original the reports from the reactionary organizations about the 'low-intensity warfare' like the report of the 'Ombudsman for Social Conflicts', without telling the characteristic of this organization. All the shortcomings mentioned, do we remark, are political evidence that the nature and existence of this '*Central Committee*' is not real, that is the only firm conclusion one can come to. In addition, we could make a never ending list that deepen this subject, as for example, they call to 'fight the LOL' but don't say how. What could they say? Since what needs to be done is to blow up this ROL with People's War, as was done with the ROL before them. This demonstrates that the call to 'fight the LOL' and their sudden '*defense of the Great Leadership*' is just an intent to cover up the non-existence of the 'Central Committee' and to hide the black counter-revolutionary action of their 'imperial envoy'.

Why do those who say that they combat the '*new LOL*' do so separated from the national and international class struggle? Why do they not

link it to the actual political conjuncture, or to the new reactionary government and its three reactionary tasks? Because it's not to their benefit to make any reports, and much less are they in a position of making a report from the Marxist-Leninist-Maoist, Gonzalo Thought class position, world outlook and method, being cronies of this rat, they don't want to relate him with the process of the old State, the political situation of the new reactionary government and the reactionary tasks. That's why those friends of the 3<sup>rd</sup> ROL prefer to 'fight' the '*new LOL*' only with stupidities, that came out of the fantastic movement inside their own heads, wanting a fight against 'don Quixote's windmills', to lead the struggle astray. That's why, they don't say anything about the one who has been put in charge of the 'dialogue' on behalf of the Humala government, to fulfill the third reactionary task of annihilating the People's War, seeking to destroy the Party and mislead the masses. In other words, the new president of the National Commission for the Development and Life Without Drugs (DEVIDA), Ricardo Soberón, the organization appointed to the 'eradication of the coca-leaf', applying the anti-drug treaty enforced by the Yankee-imperialists. Why won't they denounce that Soberón-Gorriti is the nexus of the CIA's plan, part of which was done: first, a presentation in the national and international TV of the rat José, in the end of May of 2009 and after that, the interview with the rats Raúl and Alipio in July of this present year? Because they are cronies of these rats, and, in this way, serve the plan of the CIA, within its 'low-intensity warfare', against the Great Leadership, the BPU and the Party, to annihilate the People's War. They don't want to deal upon Soberón, who because of personal history, words and deeds is an CIA agent, who serves that the CIA keeps leading the Yankee-imperialist intervention as a 'low-intensity warfare', with a limited presence of advisors and Yankee troops, because, according to this imperialist agent, a greater increase of the Yankee troops in the country would put the Party in superb conditions to lead the struggle against what it would consider a direct invasion by Yankee-imperialism. Furthermore, because of this, the ones who say, that it is all about fighting '*a new LOL*', try to cover up the main aspect of Gorriti, which is to be an agent of Yankee imperialism, confusing it with what might be a secondary or accessory thing regarding him, i.e. that he also might be an '*agent of the Mossad*'. Those who now claim to 'fight the new LOL' and seek to present themselves as last minute great defenders of the Great Leadership and Gonzalo Thought, are the same ones that since 2006 have not said anything in this regard or pronounced themselves against the open attacks of the rat José and his brood, that were signed as '*PCP (M-L-M)*' and to whom they have

been continuing to declare their *'greeting and voluntary and unconditional subjection'* and spreading their revisionist renegade positions through their leaflets. So it is clear who they are, and to who have they served these cronies of renegades and traitors, who serve the plan of the CIA to annihilate the Great Leadership. They are against fighting revisionism for the reorganization of the Party as part of the task to develop the People's War, to construct the conquest of power in the whole country, and are against the development of the RIM and the ICM. They are not for the development of the People's War as part of and in service of the Proletarian World Revolution.

Abroad, the reactionary crony of the rat José and his brood, presented himself in the end of 1999, as being an envoy of the rat Julio, to whom he expressed his *'greeting and unconditional and total subjection'*, and then, when it had become impossible to keep sustaining such a thing, he changed to express it to an anonymous *'NN'* and, after a while, started expressing very seriously and *'firmly'* his *'greeting and unconditional and total subjection to Comrade José who is in charge of the whole Party'*, and this without before having expressed a greeting and total subjection, unconditional and voluntary to Chairman Gonzalo, Great Leader of the Party and the revolution, the greatest living Marxist-Leninist-Maoist on face of the Earth, Center of Party Unity, etc. UNBELIEVABLE!, but true. For this miserable infiltrator it is possible to combine Marxism and revisionism, as infiltrator he cannot even differentiate them. Furthermore he counted with the whole impunity, or at least he thought so, for having captured the *'only'* supposed channel with the supposed *'Party leadership'*. In the beginning of May 2009, he let us know about one of the famous *'directives'* of this *'Leadership'* in which it was stated: *'Our BPU is Marxism-Leninism-Maoism, mainly Maoism'* and that in the greeting one should no longer say that Chairman Gonzalo is the Center of Party Unity, but instead that the Central Committee is. The left rejected this revisionist imposition and demanded that someone from the leadership should *'come down'* to explain this. But instead of self-criticism, as an answer we received a self-righteous reaction, claiming that what we were doing were the same as *'putting the guns against our chest so as to force someone to travel here'*. They were not in favor of giving reports and explanations regarding issues they do not have a clue about. That is why they recurred to the criollo-attitude of playing offended, so to not having to attend us and so in more than 12 years no one from Peru went to attend the Party work abroad. The list of these famous *'directives'* that express the position of the ROL of the rat José is a long one, and it encompasses, each of the points of this line to attack the Great Leadership, Gonzalo Thought,

the BPU, the GPL and the Military Line. As their call to ‘*a new Congress*’ to revoke the 1<sup>st</sup> Congress, and their ‘*first Militarized Central Committee*’, as the one that said that the ‘domination of Yankee imperialism had been broken in Latin America’, to raise the ‘*socialism of the 21<sup>st</sup> Century*’, of those like Chavez, Morales, Correa — Humala was still not there, otherwise they would have put him among the same bunch. The clear signs of these revisionist ‘*directives*’ contrary to the Great Leadership and the BPU, etc. can be easily found by reading and analyzing the documents published in the website of the ‘Red Sun’ from the beginnings of the new century until today. But this very document — that we now publish — and the defense of Chairman Gonzalo, Gonzalo Thought, BPU, the Party, the People’s War, of the apparatus and the principles, taken up by us and other Comrades, Organizations, Parties and groups abroad, shows: that once more reaction and revisionism, in collusion, ended up failing and they could not take away the organization or blow it up. They thought that they would take over it as a whole, with everything, and that they would blow everything up that would not obey them in their black and wretched purposes and the lowest and deplorable counter-revolutionary instincts of these counter-revolutionary agents of the armed gangs organized by the CIA and the old genocidal State to combat the Party and the People’s War that it leads.

The pending task of the reorganization of the Party, emerged from the necessity of defending the Party, the heroic combatant that leads the revolution, before the joint action of the CIA, the reaction and the rats of the ROL, revisionist and capitulationist, of Miriam, Morote, Cox, and Pantoja, etc. (the 2<sup>nd</sup> ROL), that after the arrest of Chairman Gonzalo (the first objective of their sinister and shadowy plan), was to go and **‘try to take from the inside the fortress which is the Party’**, and in September of 1993, they pass on to serve the plans of the CIA against our Great Leadership with the ‘peace letters’ to make ‘*an agreement that puts an end to the People’s War*’. Having failed the plan that these rats should have taken over the Party organizations; the CIA and the reaction continued their plan to take over the Party organizations. With the information and collaboration of these rats the reaction tried not only to infiltrate various Party organizations, but they also mounted fake Party organizations. The capture of the rats Nancy and Roldan in 1995 gave them a opportunity to give a new impulse to the sinister plan of reaction and revisionism; to destroy the Great Leadership of Chairman Gonzalo and to his all-powerful Thought, and to take away all that is Party, all that is revolutionary violence, all that is People’s War. To lead the Party astray, and to liquidate it from the inside and generate a series of currents,

confusion and demoralization that should make the task of the reorganization of the Party impossible and instead generate a ‘Communist Party’ that is revisionist, which is openly put forward by the ROL and then, as since this, even if it would be stillborn, is not sufficient, so they are looking to seed demoralization and take the Party from inside with the help of collaborators and infiltrators. This two ROLs, are both revisionists and capitulationists, are the two faces of the same coin of the CIA’s plan to annihilate the Party and with that the People’s War, and to try to delete the contributions of Chairman Gonzalo and of the People’s War to the Proletarian World Revolution, as part of the counter-revolutionary plan of the ‘final solution’.

We see that just like in Peru, the ROL present itself saying: that it had instructions from Chairman Gonzalo and this is how they pretended to capture our apparatus, but in a swift way we have crushed this, that same day in the year 1993 in which it was known the fake of the ‘peace letters’, under the direction of the Central Committee, as a part of the People’s War, in defending our organization, we subject firmly and unconditionally to our Great Leadership and to the almighty Gonzalo Thought, to the BPU, to our heroic combatant CPP and to all the Party accords and documents. In such a situation, then, on what are the joint action of reaction and revisionism going to focus, with the help of uncorrectable right-wingers, resented and double-faced individuals, infiltrated agents and even the ‘Party organizations’ put up by reaction itself? Since they were not able to change the colors of the PPM, they instead tried to liquidate our base units and the leadership of the organization as well as Comrades who without self-interests and under the BPU, work abroad in service of the People’s War as a part and in service of the Proletarian World Revolution. That is why, in the last months of 1999, a miserable came, saying he was sent by Comrade Julio, supposedly the one who was leading the Central Committee, but who never assumed his responsibility, as we have seen. With this ‘*organizational rank*’ he usurped the charge of responsible of our organization, and from his arrival went on with misdoings against the female Comrades and the economy of the organization and began with the systematic destruction of the generated organization, the usurpation of the leadership and to put forward, through the famous ‘*directives*’, the positions of the rat José and his brood of the ROL, only changing the appearance and name of it and then imposing it in the public documents and in the events, as can be checked, as we have already mentioned, on the web page of ‘Red Sun’ and also in the printed materials of the PPM. About that, one has to note, that these ‘*directives*’ never corresponded to the method and style of the Party and the crony of José, here abroad, while he



was praising these *'directives'*, as if they were prophecies of one of his gurus, in the worst lumpen-style way said plainly, *'I wipe my ass with the Party directives'* — referring to the Party directives dating to before the usurpation of the leadership by the rat José. Since he came abroad, he made it his task to isolate the CPP from the Parties and revolutionary Organizations of the ICM and RIM, using provocation, intrigue, and his pretended rank.

Furthermore, loyal to his practice, this crony of Jose the rat abroad, published a document in 'Red Sun', in the name of his supposed *'Central Committee'*, where he throws himself against other Parties of the ICM, whose theory and practice never interested him. He has not studied them nor even less has he traveled to try to learn about them up-close. What could you expect? A clear example of his cynical attitude (which dominates every aspect of his being), is that in his pronouncement of the 24<sup>th</sup> of September this year; he says to the Parties that leads People's Wars that one should: *'Demand of them to clarify how is it that they create New Power, where and how? Do they have a strategic plan for the whole country, to stop imperialism and the reaction from dividing the country in two when it advances?'*. Fine. These questions are ones that one should ask. But then, if they had any honesty at all, they should have started by giving the reports from the Party about which we have talked before. And they should also answer: to how and when does their supposed *'Central Committee'* build new power TODAY in Peru? And not just say, *'Now the struggles are in La Cordillera Negra'*. Over there, there are real struggles, but spontaneous ones. Who are they trying to trick with that kind of talk? And about their other question, *'do they have an strategic plan in the whole country? To stop imperialism and the reaction from splitting the country in two when it advances?'* Then, they should tell us what the actual name of the plan of their *'Central Committee'* is, and which political objectives it has and what the evaluation of the last decade or the most recent campaigns is. The only thing that they have made known is a few loose statements from the evaluation made by their *'new leadership'*, that is to say, the rats José, Raúl and Alipio saying that: *'We have resolved new things that never before had been done'* (in the decade of 1999 to 2009). And it is *'the first militarized Central Committee'*. This is repeating revisionist lies against Chairman Gonzalo and the Party. If they make those questions to other Parties, at least they should be able to answer them themselves concerning the reality in Peru. And when they are on it, they could tell how many Regional Committees there are which are following their *'Central Committee'*. In Huallaga, no one is aligned or subjected to them, nor in the MRC. It's enough to see the lists of the actions,

published before in the ‘Red Sun’, to recognize how many armed actions have happened outside these two Committees to come to conclusions. In reality, what they want is to cover up, with their cries to the skies and ‘*denouncing*’, is that they do not represent any Party Committee. Because what exists in Peru are Party Committees, Cells and Party members, as well as combatants and masses, but there is no centralized organized work on a national level, that is subjected to the 1<sup>st</sup> Congress, to the BPU and to the plans established in the 3<sup>rd</sup> Plenum of the Central Committee. If the situation would be different than so, it would be very easy to show it. People’s War is war, which is the continuation of politics with other means, a higher form of fighting with actions of war. Whomever says ‘People’s War’ without armed actions, is not proposing anything else than ‘*the political war*’ of the ROL with the ‘peace agreement’. In the whole country the masses are rebelling and in a lot of places, as it is confirmed by everyone who has traveled in the country in the last years, there are Comrades, who are waiting for the possibility to re-join. The problem is not in the lack of objective conditions, those are excellent to develop the People’s War; the problem is not either in the lack of forces that could be quickly organized, that is what there is the most; the problem is that no one does the work of the leadership; there is no national leadership which hold on to the Great Leadership of Chairman Gonzalo and develops the People’s War according with the decisions and plans of the Party. To know this is necessary to be able to rend services to that such a leadership can be generated in Peru, from abroad we can not have the intention to lead, but we can help facilitate the work of the Comrades, serve the development of the People’s War, in Peru. The work that has been done by the rat José’s crony abroad, destroying the PPM apparatuses and trying to change the color of what is left of it, spreading disinformation, intrigues, lies, and this for more than a decade, and that since May 2011 he has been doing it at high-speed after he split from the PPM usurping the name of the organization and the ‘Red Sun’, can only be part of the plan of reaction in conspiracy with José and his brood of rats, in service of the counter-subversive war, in service of the counter-revolutionary war and against the World Revolution, the ICM and the RIM.

Their questions reveal that they are just like the ROL, who come with the hoax of the ‘peace agreement’. Let’s remember that those for the ‘peace agreement’ did say: ‘*RIM — Parties only by name*’. Isn’t it the same that is put forward by the cronies of José abroad? See their attitude along the years, particularly from the year 2005, towards the Parties and Organizations of the RIM and the ICM as a whole; they did not even agree to call the

People's War in India a People's War. They ferociously opposed the actions developed as a part of the international action week in April the current year, and only against the will of the miserables was it possible to do some actions in some locations.

So, it is a process of more than a decade of struggle inside the PPM, between the left and the right, a right that is headed by this counter-revolutionary agent who we are denouncing, with the position and under the instructions of the rats of this 3<sup>rd</sup> ROL and he is subjected to their leadership. A process which ended in May this year, where they finally usurped the leadership of the apparatus and the website 'Red Sun'. This is how this miserable, taking a few by surprise, definitively split off from the apparatus, with the false idea that he had already finished it off and ended the Marxist-Leninist-Maoist, Gonzalo Thought, mainly Gonzalo Thought, Party work and that he would be able to portray himself as representative of the Party and count on a fake organization and a fake voice so as to keep usurping the name of the CPP and the PPM, and serve the counter-revolutionary goals of his masters, reaction and revisionism. Furthermore he thinks to live comfortably in his place, as a citizen of one of the imperialist countries that he claims to hate. But nothing is given to people of his low kind, and he won't ever be able to enjoy a life in peace, that is the fruits of his counter-revolutionary evil.

It's necessary to make clear, until the first week of May 2011, 'Red Sun' was a red flag; during a long time revisionism has infiltrated with its positions, that's why we can find positions that are eclectic in it, with expressions of convergences and nuances, but its fundamental character has been that of a red flag. Since May 2011 the left has been totally suppressed in the organization and no opposition to the sinister work of the cronies of José abroad remained and with this the 'Red Sun' changed color, and is now a black flag. That explains their desperate cries and vulgar attacks against the left. That is why they have gone so far as to spread a video from the reaction, spread during years by the miserable 'Victor Fernandez' from Spain, they want to paint themselves red but their reactionary class position makes them so stupid that can not differentiate between red and black.

Because of where our apparatus is located, in a geographic sense and in organizational system, it's logical that there are a lots of things that we don't know. It's also so regarding those Committees in Peru that heroically are continuing combating and resisting for the BPU and the People's War. It would be ridiculous if we pretended to know everything. But those who pretend to be the '*Central Committee*', they have to know everything

and they are obliged to know, because if they do not know they are not the national leadership, then they are not a Central Committee more than by name. Therefore let those who are obliged answer, put themselves on the level of the ideology and political struggle and they should not pretend to surprise the unknowing. What one should do is to reassure with firmness the road ahead, establish plans and fulfill them — everything else is mere fairytales.

But since we are not promoting vain illusions, the most consequent Party Committee in the middle of the fire of the People's War should assume its urgent and delayed task of the People's War, the revolution in Peru and the World Revolution demands it. Hence, the delayed and pending task of the general reorganization of the Party must be done by crushing revisionism as a part of the task to lead the People's War. This task is more urgent than ever. As has been established by the Party:

Since the problem of the internal struggle is a question of cardinal importance in Party life, it is relevant to add the following question: Revisionism is the main danger for the Party and the revolution, and for this reason it must be implacably combated and crushed. Our Party has purged itself but the struggle must continue, in the final analysis the armed struggle in our country would never have been initiated nor developed without first sweeping away the ROL of that time, and today we can say that without sweeping away the capitulationist and revisionist ROL totally and completely we can not conquer power countrywide. We know well that internal causes are definitive, and for that reason it should remain clear, that if the reaction could do some damage to the revolution in our country since 1992, it was because revisionism helped it, served it, it facilitated things. This is a very serious lesson which we must never forget. Therefore, if we totally sweep away revisionism and finish purging our ranks, embodying to the root the BPU in the midst of the People's War, we will be fortified and we will be invincible.

Our struggle is definitely a part of the struggle that is going on at the world level between revolution and counter-revolution. And in the ICM, and as a part of it, the RIM, it is expressed as the struggle between Marxism and revisionism. The situation we face in this moment is complex and in this document we pointed on the most urgent questions. There is much more work to do to, to deepen and develop. One must also see the process of struggle that we have gone through in the apparatus, the self-criticisms and criticisms for us to do in front of those it concerns; this is what we will continue to do. Continuing our daily work in the middle of the storm, tearing down walls, as Chairman Gonzalo teaches us:

[...] the forging of Communists is like that, in the turbulence and difficulties, never in calm waters. They say that the one who wins is the one who resist one minute more, and we know how to hold on longer since we have the true ideology: Marxism-Leninism-Maoism, Gonzalo Thought that arms our souls and arms with the indisputable truth. The unevenness, as light or profound as it may be, tempers us, forges and steels us; Chairman Mao said: **‘in the hard times, we must keep in mind our victories, to see our shining future and increase our courage’** [...] what we are facing is nothing more than a part of the unevenness and this is forging us for the complex moments that every revolution goes through; Communism teaches us to be prepared even for defeat, Chairman Mao said that after two defeats and two victories they understood the laws of the Chinese Revolution [...] the life of the Communist is struggle, Marx replied to his daughter in one occasion: what is happiness? It’s struggle; years later Chairman Mao learned: working is struggle.

To conclude, our Great Leader, Chairman Gonzalo; our ideology, Marxism-Leninism-Maoism, Gonzalo Thought, mainly Gonzalo Thought; our Party; and our apparatus for the Party work abroad, the PPM — they are standing tall, they have not been able to blow it up in a thousand pieces and they never will. This is our history; this is how we embody the fight against revisionism to the death and the pending task. The future is ours, we have a beautiful sentence: we are condemned to win.

Starting from reaffirming our greetings and full, conscious, unconditional and voluntary subjection to Chairman Gonzalo, Great Leadership of the Party and the revolution, the greatest living Marxist-Leninist-Maoist on the face of the Earth, continuator of Marx, Lenin and Chairman Mao Tse-tung, center of Party unification and guarantee of triumph until Communism; to our all-powerful ideology, Marxism-Leninism-Maoism, Gonzalo Thought, mainly Gonzalo Thought; to the Communist Party of Peru (CPP), to its leaders, cadres and militants, who in the present circumstances persist in holding high the invincible banner of People’s War, strictly subject to our Party principles and very particularly to our Great Leadership, crushing with People’s War the plans of imperialism, reaction and revisionism, pledging Communist heroism in abundance in the struggle for the general reorganization of the CPP. Thus, very especially our full and complete subjection to the 1<sup>st</sup> Congress of the Party, Marxist Congress, Marxist-Leninist-Maoist,

Gonzalo Thought, mainly Gonzalo Thought, which established our Base of Party Unity (BPU) with its three elements: the ideology, Marxism-Leninism-Maoism, Gonzalo Thought, mainly Gonzalo Thought; the Programme; and the General Political Line, with its center, the Military Line; as well as the 3<sup>rd</sup> Plenum, historical and transcendental, and the Speech of Chairman Gonzalo of September 24<sup>th</sup>, 1992, which shines victoriously and powerfully before the world as a weapon of combat, as well as the Party plans and accords that correspond to its application. We salute the combatants of the People's Liberation Army (PLA) and the masses of the New Power who despite all the genocide and revisionist betrayal remain unwavering in their commitments to the Party and the revolution. We salute the Marxist-Leninist-Maoist Parties and Organizations worldwide and the People's Wars under their leadership, we salute the International Communist Movement (ICM), marking with fire all the attempts of Avakian and Prachanda's revisionism, which led to the de facto liquidation of the Revolutionary Internationalist Movement (RIM) with the eagerness to erase everything that could be advanced with it, mainly thanks to the struggle of Chairman Gonzalo and the CPP, with People's War. We renew our commitment to defend our Great Leadership against all attacks, wherever they come from and to pay the necessary price.

This reaffirmation is not and cannot be a mere salute to the flag, an empty formula or a cliché, but a militant Communist expression of struggle for the general reorganization of the Party, in a fight to the death against revisionism and the reactionary plan to destroy it, to annihilate the People's War. Here, abroad, this commitment today has to be embodied in unmasking and crushing the sinister traffic with the name of the Party, its generated organizations and means of agitation and propaganda, on the part of a counter-revolutionary element that fulfills to the letter the plan of imperialism, mainly Yankee.

Many comrades at the international level are confused, they don't know how to orient themselves, they ask themselves: 'Who is who? There are so many factions... there is nothing?' This is not strange, because this is precisely what the imperialist plan is aiming at. The position of the Communists has to take its starting point in a class position, in a principled position and in the light of our common universal ideology, Marxism-Leninism-Maoism, mainly Maoism, to see the concrete facts of the class struggle, the

struggle between armed revolution and counter-revolution in Peru. It is not a question of starting from good wishes, in some cases, or from petty interests in others, but to remember what Chairman Mao emphasized, the class character and the relation with practice, which our conception of the world has. First, position, and, starting from this, we see practice. It is not enough to do one without the other — to do only the first is dogmatism, and to do only the other is pragmatism in the style of Avakian. Both are needed.

At present we apply this fundamental method, to clarify the situation and see who is who. This by wielding the combat weapons that Chairman Gonzalo and the Party have endowed us with.

## 1. BY WAY OF CLARIFICATION

In order to be as clear as possible, to facilitate understanding, it must be clearly stated that ‘the multiple factions’, on which imperialism, reaction and its revisionist lackeys always insist, do not exist as such. What exists in Peru is:

— The 2<sup>nd</sup> Right-Opportunist Line (ROL), revisionist and capitulationist, of the hoax of the ‘peace agreement’, that is, the Movement for Amnesty and Defense of Fundamental Rights (MOVADEF) with Julio (i.e., the traitor of Huallaga who presents himself as Artemio). These rats have long been outside the Party, even this line was structured outside the Party.

— The 3<sup>rd</sup> ROL, also of a revisionist and capitulationist character, what reaction presents as ‘the VRAE faction’, headed by the rat José and his brood. This line has been structured in the Party since the end of the 1990s.

— Committees, cells of different Party levels, and in their environment, concentrically, units of the PLA and the organizations of the New Power/Front, dispersed, acting until now without centralized national leadership but firmly subject to the Great Leadership, our ideology — Marxism-Leninism-Maoism, Gonzalo Thought, mainly Gonzalo Thought — and the BPU, who are fighting for the general reorganization of the Party in the midst of the People’s War.

This is so, let there be no doubt.

The Central Committee for years has been blown up by the convergent action of the rat José and the rat Julio, in collusion with Peruvian reaction, in fulfillment of the plan of Yankee imperialism. Therefore: what the counter-revolutionary element, which has usurped the magazine *Red Sun*



and its web page, affirms, is pure lies. It is a story. It is part of the enemy's disinformation campaign, it is part of the psychological warfare (a fundamental and indispensable component of the "low-intensity warfare" led by Yankee imperialism). In the document published in October 2011 — **FOR THE GENERAL REORGANIZATION OF THE COMMUNIST PARTY OF PERU AS PART OF THE DEVELOPMENT OF THE PEOPLE'S WAR TO CONQUER POWER IN THE WHOLE COUNTRY! GRASP GONZALO THOUGHT TO SOLVE NEW PROBLEMS!** — we have pointed out the guidelines on how this process took place, that is to say, how it was possible for the Central Committee to be blown up. We think that it is not necessary to repeat here everything that was exposed there, we recommend that such a document be studied again.

Assuming our commitment, here and concretely, to serve the general reorganization of the CPP, promoting the reorganization of the Peru People's Movement (PPM), the organization generated by the Party for the Party work abroad, we demarcate, reject, condemn and mark with fire the call to capitulation of the counter-revolutionary subject that usurps the name of the CPP, of its Central Committee, of the PPM and of the magazine *Red Sun*, as we have denounced in our document of October 2011.

The subject in question has published, in the name of the "PPM", the rag of a document: *'AGAINST WIND AND TIDE, THE GLORIOUS COMMUNIST PARTY OF PERU MAINTAINS THE ROAD OF THE PEOPLE'S WAR!'*, last March of this year, on the usurped web page *Red Sun*, in which the reactionary position that he represents and defends is concentrated.

In that document, he expresses his role as the true spokesman of the government of the fascist, genocidal and country-selling Ollanta Humala and calls for capitulation: in Peru, to the leaders, militants, combatants and masses who persist in the People's War, in the complex and difficult situation of the bend in the road through which the People's War, the Party, the Army and the Front/New Power are going through; and, abroad, to those of us who work with the particular responsibility of fulfilling the tasks established by Chairman Gonzalo for the PPM: To serve to create public opinion favorable to the People's War in Peru, to contribute to the reconstitution of the Communist Parties and to serve the World Revolution and, within this, to fulfill the tasks related to RIM. Tasks that we fulfill by developing the

two united and inseparable campaigns: the campaign for Maoism and the campaign for the defense of our Great Leadership, Chairman Gonzalo, and Gonzalo Thought. The latter is like the key link, because the successful development of the campaign for Maoism and of our three tasks depends on its fulfillment.

In their filthy rag, with full brazenness, impudence and trying to deform the principles of the Party and of the People's War established in the 1<sup>st</sup> Congress of our Party and endorsed by the experience of more than 31 years of invincible People's War, they say:

*'[...] For the Party, the question is to continue to anchor in the mass work. Armed actions in this situation will continue to expand the scope of the axis of the People's War; the countryside is still the main thing, but not the jungle; and with the leadership in the countryside, to focus on mass work. Thus, the Party continues to assume its responsibility as the vanguard of the proletariat, leading the People's War, and as the Red Faction within the International Communist Movement. In this task, the PPM firmly assumes its role of serving the ideological struggle against revisionism on a world level [...]'*. (Our underlining.)

In the above quotation is where the crux of the matter lies of this whole mamotreto, as well as of the others, which they have been publishing profusely on the Internet in fulfillment of their *'ideological struggle'* against the Peruvian Revolution and the World Revolution, trying to cover it up, with their already well-known double-faced counter-revolutionary style, as a struggle *'against revisionism on a world level'*. It is in this quote, in which his reactionary position and conception is summarized, which, sowing more confusion on all levels, pretends to present it as Marxist-Leninist-Maoist, Gonzalo Thought, while disarmed, sinisterly and with all its brazenness disfigures it to the point of turning it into counter-revolutionary poison to propagate capitulationism and revisionism, to serve the need of imperialism and reaction to annihilate the People's War, thus serving the bureaucratic road against the democratic road.

## **2. 'RED SUN NO. 37', AN IRREFUTABLE PROOF OF THE REACTION-ARY PLAN**

After this, it has published a spurious *'Red Sun No. 37'*, in which all its contents are marked by the counter-revolutionary position and

conception that we are here breaking into pieces, as we will demonstrate by touching on some essential questions that are dealt with in it.

But, first, it is necessary to deal with the position assumed by these two-faced individuals, in view of the events that took place in the Convention Valley in Peru, starting on Monday, April 9<sup>th</sup>, in which an armed action of the ROL led by the rat José took place, in which, according to the reactionary press:

*‘They took over the installations of the contractor companies of the Gas de Camisea project, located in the town center of Kepashiato, district of Echarate, province of La Convención (Cusco). Taking hostage several workers of the companies TGP, Skanska and Construcciones Modulares.’* (Note that appeared in all the national newspapers, as it was information from the Ministry of the Interior.)

After which, large military operations were carried out by the Peruvian Armed and Police Forces under the military command of the Southern Command of the Yankee Army, under the name of Operation Liberty. Yankee intervention, which was revealed by the destruction, by the attackers, on the 12<sup>th</sup>, of ‘a PNP helicopter’, as first reported by the authorities, which later turned out to be a helicopter of the Yankee DEA, the UH1H Huey II helicopter that collapsed. In addition, Yankee military commanders have been entering the country since January, they say to ‘coordinate’ Operation New Horizons 2012, which will take place from May to August of this year.

Continuing with the recounting of the events by the press, on April 14<sup>th</sup> the newspapers reported that the armed group released the 36 workers.

*‘The Shining Path members demanded a payment of 10.000.000 dollars to release them. It was not yet clear if the companies paid any ransom, but experts said that it is possible that the captors and the companies reached agreements that led to the release, in which the Armed Forces did not participate.’* (As reported by international press agencies and most of the country’s newspapers.)

In the military operations under the command of the Yankees, massive bombing and racketing of the Convention Valley and other valleys of the Apurimac and Ene rivers, which extend from the department of Cuzco, in the south, to the limits of the department of Cerro de Pasco, in the center, causing deaths, injuries and forced displacement of the peasant populations

of this vast area of our country, which covers more than 300.000 Km<sup>2</sup> of territory, is being carried out.

Faced with these facts, the reactionary government has called for ‘national unity’ and condemned the ‘kidnapping of the workers’ to hide the Yankee military intervention and the genocide against the people that they have been committing.

In view of the facts, we denounce the military intervention of Yankee imperialism and the fascist, genocidal and fatherland-selling government of Humala. We denounce that, the current military operation that they are conducting under the name of Operation Liberty, is not just any operation but one of great proportions, in which, under Yankee command, combined forces from different parts of the country are participating, bombing and raiding vast areas of territory and targeting the civilian population.

So, we are not before one more act of Yankee intervention in our country, nor are we before a simply repressive decision to ‘establish the authority’ of the new reactionary government; rather, Yankee imperialism is intervening militarily in application of what they understand to be threats to their security, in the context of weak states, etc., as they are doing in Mexico, with the Merida Plan.<sup>1</sup> According to this concept of imperialism, this ‘*demands the coordination of civilian and military actors*’, the integration of security and development practices, as Humala and his government have been proposing, that with these operations and genocide, their hesitations are over and they are now developing more openly a fascist, genocidal and country-selling government, under the call for ‘national unity’, counting on the support of the Armed Forces.

We denounce this new sinister genocide that they are committing against our peasant masses to subjugate them, to set a bloody precedent and to make them submit to the hegemonic and counterrevolutionary plan of Yankee imperialism and that of the fascist, genocidal and country-selling government of Humala.

Regarding the actions of the 3<sup>rd</sup> ROL and the character of this, we reaffirm what was pointed out in our document of October 2011, which states:

**‘It is necessary to see what the ROL of José and his cronies puts forward accurately to be able to demolish and sweep away all the convergences with this ROL. Its content is feudal-imperialist, it is against**

**the Great Leadership of Chairman Gonzalo, it is against Marxism-Leninism-Maoism, Gonzalo Thought, it is against the Party and against the People's War. They aspire to bring forward the Four Changes: change in leadership, denying that the Center of Party Unity is our Great Leadership; putting forward the Central Committee as a supposed Center of Party Unity, negating what was put forward in the 1<sup>st</sup> Congress about the role of Chairman Gonzalo, instead of a proletarian leadership they try to impose a leadership of warlords; change in line, negating the GPL and its center the proletarian Military Line, they want to impose their revisionist ,*new programme*' and their bourgeois military line, negating the CPP as a Marxist-Leninist-Maoist, Gonzalo Thought militarized Party — trying to impose their ,*Militarized Party*' which is nothing more than a variant of the miscarriage of a ,*political-military organization*' of the rats of the Túpac Amaru Revolutionary Movement (MRTA), and; they want to change the People's War into a mercenary struggle in the service of the highest bidder.”<sup>2</sup>**

We call to serve the reorganization of the CPP in the midst of the People's War fighting to the death against revisionism, specifically against this 3<sup>rd</sup> ROL, revisionist and capitulationist, without neglecting to continue the struggle against the 2<sup>nd</sup> ROL, because they are nothing more than two sides of the same coin of revisionism and capitulation at the service of imperialism and reaction.

And, in the face of these facts, what position does the counterrevolutionary spokesman take, who from the usurped page of *Red Sun* spreads his sinister propaganda?

The one that corresponds to him according to his true class nature, that of the true spokesman of Operation Liberty carried out by Yankee imperialism and Peruvian reaction, following his call, gave him a chorus. Logically, as a double-faced element, he issued a pronouncement entitled: *'REJECT AND CONDEMN THE COUNTER-REVOLUTIONARY ATTACK OF THE ,LEFT'-OPPORTUNIST LINE AGAINST THE CLASS, STOP ARMED REVISIONISM, LONG LIVE THE PEOPLE'S WAR!'*, in which he presented himself as a great fighter against the revisionism and capitulationism of the 'Left'-Opportunist Line" (LOL), that is, the 3<sup>rd</sup> ROL of the rat José. Against which he pointed as if it were the main enemy, and not as what it is, revisionist and capitulationist servant of imperialism and reaction. And

changing tactics, he went from inflating the 2<sup>nd</sup> ROL and its MOVAREF (seeking to cover up the 3<sup>rd</sup> ROL), as he had been doing until his March pamphlet, to attacking it as the main enemy, joining the government's call for 'unity'. In order not to take a position against the main enemy, imperialism and reaction, in order not to take a position before the intervention of Yankee imperialism and its lackey, the government of the day. To hide the genocide that they are committing against the peasantry. In short, they pointed against the armed action of the 3<sup>rd</sup> ROL, to throw dirt in the eyes of the people, to seek to hide the imperialist intervention and the genocide against the people.

In its pronouncement, very ready and opportune for the reaction, usurping the name of the PPM, etc., among other things it says:

*"The PPM reaffirms the position of our Party, the CPP, its Central Committee and its entire system of Party leadership, to reject and condemn the miserable attack of the traitors of the LOL against the class and the workers in Cuzco. It is an attack against our class, which clearly expresses the class position of these wretches and their condition of traitors of the revolution and our people. Furthermore, it is an attack that shows how the LOL serves and is part of the counter-revolutionary plan of imperialism, reaction and revisionism in Peru and worldwide to spread revisionism, confusion, split and capitulation in the revolutionary ranks, aiming against Maoism with its 'peace agreements', amnesty, parliamentary cretinism and armed revisionism. See for example the latest news about the kidnapping in India in the context of this imperialist plan, with which they seek to present all this armed revisionism as 'Maoism'."*

And in another paragraph he adds:

*"In this context one must see the actions of the LOL and that of the miserable Artemio, who ended up as a drug dealer with his own maceration pit."*

And to try to cover up their attack on all that is revolutionary violence with the pretext of leading against 'armed revisionism', they say:

*"For us, we develop the armed actions to build the new society, building the Party, the Army and the Front in the midst of the People's War, linking it to the heroic struggles of the people for their daily demands [...]"*

But, that they carry out 'armed actions' is pure babble, which he repeats at every moment to continue with the deception that he represents a

‘CPP’, his ‘Central Committee’, since they do not carry out any, as can be seen in the very pages of his spurious ‘*Red Sun* no. 37’, where he cannot report any of his ‘armed actions’, despite the fact that there he claims to have six ‘Regional Committees’, but none of them is capable of reporting a single armed action. The armed actions, which appeared in previous years in *Red Sun* as ‘List of Actions’, were made up from what appeared in the reactionary newspapers, that is, from sources of reaction, in the absence of Party reports; since the double-faced counter-revolutionary subject, who claimed to be the representative of the Party abroad for more than 12 years, never reported any of them. For that reason, these ‘lists’ presented actions of the ROL of the VRAE and actions of the ROL of the Huallaga, as their own actions.

Moreover, neither this subject, nor the ‘Committees’ that he says support him, as we read in his ‘pronouncement’, appearing in that same ‘*Red Sun* no. 37’, present a report of their own, partisan, of their own ‘mass work’ and of the struggles of the masses — which they call ‘social conflicts’ just like the reaction — to which they cynically say they ‘listen to their heart-beat’; they only refer to these struggles, they ‘greet’ them, following a ‘greeting’ of their ‘Central Committee’, the only thing it does is to enumerate some struggles, repeating, plagiarizing a report of the ‘Ombudsman’s Office’ (institution of the old State set up to divert the struggle of the masses towards ‘dialogue’, saying that the genocidal State watches over their ‘human rights’, when they violate them every day). Whoever wants to verify this, should read the alleged pronouncement of the ‘Six Regional Committees of the CPP’ (‘*Red Sun* no. 37’, p. 3 et seq.), repeated in their article on the ‘National Situation’ (p. 14 et seq. of the aforementioned ‘*Red Sun*’, as a quote from the pronouncement of their ‘Central Committee’).

We suggest that they compare this ‘greeting’ of their ‘documents’, with the ‘reports on social conflicts’, prior to those ‘Internet leaflets’, which have never circulated in the country. But, whoever does not want to take that trouble, it may suffice to see the style in which the list of struggles of the ‘greeting’ is made.

Going on, as for the pronouncement of the counter-revolutionary spokesman, to put it briefly, it confirms once again what he is and his nature as a double-faced reactionary agent, of this subject who pretends to present himself as an ‘envoy of the CPP’: he uses a pretended denunciation against

an armed action carried out by the ROL of the rat José, whom, he joins with the rat Artemio of the other ROL, to accuse them of drug traffickers, that is to say, they are no longer revisionists and capitulationists, but mainly ‘drug traffickers’, ‘kidnappers’.

**Why does he do this?** Because it believes that the time has come, hiding behind the struggle against the actions of ‘armed revisionism’, to raise and try to give ‘legitimacy’ to the hegemonist and counter-revolutionary plan of Yankee imperialism, which it is developing through its Southern Command in our country and other Latin American countries, as ‘war on drugs’, ‘war against narcoterrorism’, ‘counter-insurgency warfare’ (a concept that according to the field manual of the Yankee Armed Forces (Field Manual of the Yankee Armed Forces, 2007)<sup>3</sup>) covers the war against the ‘actions of organized crime’, which ‘includes kidnappings by irregular armed groups’, etc.). Hegemonist and counter-revolutionary plan which is served by the hoax of the ‘peace agreements’, all the sinister attacks against our Great Leadership and Gonzalo Thought, as well as this sinister pronouncement.

With the pronouncement, using the ‘fig leaf’ of the ‘struggle against armed revisionism’, this subject openly serves to create public opinion favorable, not only to the Yankee intervention in Peru and Latin America, and offers his service to try to hide the genocide it is committing, but also, he puts himself directly at the service of the present government, which is at the head of the old bureaucratic landlord State, submitted to imperialism, mainly Yankee. Thus, also, they put themselves concretely at the service of the third and main task, the need of imperialism and Peruvian reaction, that of annihilating the People’s War.

**And internationally, where does this pronouncement that we are crushing, rejecting and condemning point to?**

It aims against the People’s Wars and the revolutionary and anti-imperialist armed struggles taking place in the world. That is why in their ‘*Red Sun* no. 37’, internationally, they only focus on the other hill and not on how the New Great Wave of the World Revolution is developing; that is why they do not highlight at any moment the development of the actions of the People’s Wars and the armed struggles of liberation, which daily beat imperialism and reaction in India, in Afghanistan, in Iraq, in Palestine, etc. Therefore, without any knowledge and concrete analysis of the actions



carried out by the Communist Party of India (Maoist) (CPI (Maoist)) as part of developing the People's War, he takes a news item from the press taken out of context to attack the comrades in India as armed revisionists, accusing them of also carrying out kidnappings and not actions of the People's War. That is to say, he accuses the Indian comrades of doing 'armed revisionism', that they carry out 'kidnappings', just as much as the '*armed action carried out by the revisionists of the LOL*'.

**Why do they proceed in this way, why, just now, after having presented themselves for 12 years as the personal representative of the rat José, are they now attacking him?**

In general, both in Peru and worldwide, to use his femetitious struggle against 'armed revisionism', against the 'armed actions' of 'revisionism' to seek to discredit the armed actions of the People's Wars and the armed struggles in Peru and the world, that is, to attack in this way the main form of struggle of the peoples of the world, the armed struggle, revolutionary violence, the People's War, that is, to condemn armed actions under the pretext of fighting against armed revisionism, and to say that what corresponds is to do 'mass work', mass work which thus separated from the People's War, is nothing more than calling to fall in line with the 'mobilizations of the masses' led by all kinds of revisionist and reactionary leaders.

For this reason, let us take up now, something more of their '*Red Sun* no. 37', in it, following the style of their 'Party' documents and with the same purpose, they publish a map of a monthly report of the 'Ombudsman's Office', published in the newspaper *The Republic*, and so that there can be no doubt as to what their ideological dynamic is, these, in the same article on 'national situation', below the quote of the supposed pronouncement of the 'Central Committee of the CPP', that is of their own 'Central Committee', they say:

*'The current situation in Peru is marked by the sharpening of the class struggle, whose symptoms are, mainly, the development of the People's War led by the CPP and the social conflicts that run through the entire national territory (among others Ancash, Lima, Cajamarca, Piura, Junin, Huancavelica, Ayacucho, Madre de Dios, where, in clashes with the police there have been 3 dead and 36 wounded) in defense of mining and natural resources (see map in infographics of the newspaper ,The Republic' 15.03.2012).'*" Quote that we tear apart a little further on.

But see, also the following quote, from their article on ‘National Situation’ of their *Red Sun* no. 37”, how they stand behind the authorities of the old State, and say there:

*‘Greet the Peruvian people who have been fighting and shaking the country, conquering their demands in the midst of heroic journeys; to enumerate some of them [...] the mobilization of Tacna villagers together with the regional authorities against the Southern mining company project.’*

Who are these ‘authorities’, who are they? They are nothing more than small-time representatives of the regional power of the old State. As a reactionary agent, they have to appear more brazen and crafty than the revisionists Avakian and Prachanda, who are being targeted to cover up their real role in the class struggle.

Contrasting the reality, with what this wretch who usurps the name of the CPP says, that they carry out ‘armed actions’ is pure babble, which he repeats at every moment to continue with the deception that it represents ‘armed actions’, ‘mass work’, etc., it is very clear that the organization it really represents is a false reactionary construct; as can be seen from everything that comes out of its own jaws, from what is written and what is not, in the pages of its spurious *Red Sun* no. 37”; and moreover, they cannot show a single material proof of its real existence: such as leaflets, photos, reports of Party meetings of any level whatsoever, and this for more than 12 years.

That is why the ‘action lists’ of the issues prior to the spurious *Red Sun* no. 36”, were mostly a mixture of actions of the VRAE ROL and actions of the Huallaga ROL, presented as their own actions in the ‘action lists’ of the *Red Sun* prior to the spurious issues ‘36’ and ‘37’ — ‘lists’ made up abroad as we have already pointed out above.

Now he is saying, to continue with his deception, that José’s ‘LOL’ has only been structured a year ago, when at the beginning of June 2009, he took a position on the interview granted by the rat José to Peruvian TV, in which, José personally pointed out: that since July 1999, he and his brood had broken with Chairman Gonzalo and his Central Committee, whom he insulted as ‘revisionist’, ‘traitor’, ‘terrorist’, etc. Moreover, this double-faced counter-revolutionary subject, in March 2011, made propaganda for that interview, showing parts of it as if they corresponded to the CPP (in an event organized in Sweden on the occasion of March 8<sup>th</sup>). In addition,

whoever wants to see the course of the revisionist and capitulationist ROL of the rat José and its structuring, can do so by entering their website, where there is documentation since 2006.

### **3. THE SPOKESMAN OF THE REACTION SERVES THE PLAN OF IMPERIALISM AND THE REACTION**

Well, we have already seen that this reactionary spokesman has nothing to do with People's War; and neither does he have anything to do with the struggle of the masses in and for the People's War. That is to say, he has nothing of the Left, pure smoke, there cannot be more false than these. Not only that, but in trying to document his deception, he only succeeds in choking on his own lie.

And his deceptions are exposed at every turn, because this guy has, not by a long shot, nothing of our position and conception. Therefore, it is necessary to disembowel that previous quote, in which he wants to equate 'People's War' with 'social conflicts', as 'symptoms of the sharpening of the class struggle'. Everyone knows that the terminology of 'social conflicts' is used by reactionary sociology, it does not correspond to historical materialism, but to reactionary sociology that preaches the possibility of social peace, that with dialogue social conflicts can be solved, because there are no antagonistic, irreconcilable class interests between exploited and exploiters, between oppressed and oppressors, i.e. class struggle, whose highest development is the People's War. Which is not a simple symptom, but rather, the historical development, the development of the class struggle has brought us here, as Chairman Gonzalo tells us.

Therefore, this reactionary spokesman cannot confuse anyone with his imposture, because the development of the class struggle has brought us to its highest form, the People's War, this is the main form of class struggle of the proletariat and the people in our country, to which the Army corresponds as the main form of organization. It is by developing the People's War through actions, through the PLA, that the CPP carries out the work of the masses, uniting the struggles of the masses for their immediate demands to the struggle for power through the People's War. In this way the mobilization of the masses is raised to higher and higher levels.

To say that the *'People's War [...] and the social conflicts'* are *'symptoms of the sharpening of the class struggle of the present situation'*,

as it is written in this spurious ‘*Red Sun* no. 37’, is nothing more than lowering the People’s War to a conjunctural factor or symptom, nothing more than a reactionary bungling; while for these bunglers, another symptom would be, the ‘social conflicts’. Which, according to the definition of reaction, of the ‘Ombudsman’s Office’, include ‘*conflicts*’ of various types, ranging from disputes between authorities at ‘*local, regional and national levels*’, ‘*environmental conflicts*’, of ‘*electoral claims*’. In doing so, it is complying with a reactionary mandate, that is, with the task of the ‘Ombudsman’s Office’ to publicize the existence of these ‘*conflicts [...] as a warning signal addressed to the State, the companies, the leaders of the social organizations, the media and society in general so that decisions are taken to conduct the conflict by means of law and dialogue and to avoid violent outcomes.*’ (‘What is the report on social conflicts?’, Ombudsman’s Office of Peru, can be read in each of its reports.)

Then, to this ‘symptom’, corresponds the ‘dialogue’ and ‘agreements for its peaceful solution’. And, according to these, when considering the ‘People’s War’ as a symptom, what would correspond, according to the logic of ‘conflict resolution’? Following the thread of this reactionary bungling, we arrive at what they do not dare to say, the ‘peace agreements’ (imperialism’s plan).

Below the commented quote, they write: ‘*On the hill of the people the great struggles take place, where no one can deny the role of the CPP.*’ (‘*Red Sun* no. 37’, p. 15). With which they put on the table that in spite of their efforts to try to deceive, they are not in favor of merging the struggle of the masses with the People’s War. Rather they speak of ‘great struggles’ within which are not the actions of the People’s War, so what they have in their heads, what they are propagandizing is the ‘People’s War’ of those of the ‘Peace Accord’, with their ‘political war’, ‘without bloodshed’. As has always been openly maintained by the faithful accomplice of this reactionary subject — the element who works as the technician of the usurped web page and who is the only one who pays attention to him in the country where our main base was abroad — and who on various occasions has repeated, that the ‘*People’s War is political war*’, to say also, that he ‘*does not want a People’s War in [his] own country*’.

This same false ‘representative of the CPP’ and the reactionary, who from Peru or from abroad, acting as ‘contact’, in June 2003, wrote a

directive in the name of their ‘Central Committee’, in which they raised a similar action to that of April 9<sup>th</sup> in La Convención, against which today they have torn their garments — that of the Techint — of the 3<sup>rd</sup> ROL. Surprising? For us: No! Only confirmation that he has never represented the Party, but has always acted as an agent of reaction. We denounce this counter-revolutionary action of supplanting the contact of the Party with its organization generated for the Party work abroad, the PPM. This action is aimed at conjuring away the general reorganization of the CPP, to annihilate it and annihilate the People’s War, to liquidate the PPM and serve the liquidation of RIM, in convergent action with that of Avakian and Prachanda, to attack the Communist Parties and revolutionary organizations of the ICM and to seek to discredit the People’s War and armed struggles for national liberation.

In this way, what is real and concrete is that this spokesman of reaction serves the plan of imperialism and reaction in Peru and at the international level, on this level, when in his rags he attacks the People’s War in India, filling it with counter-revolutionary denunciations, thus concretizing, what he understands as the task of his ‘PPM’ agreed upon by his ‘Central Committee’, that:

*‘The PPM firmly assumes its role of serving the ideological struggle against revisionism at world level.’* (Our underlining.)

Their ‘ideological struggle’ is to attack the Maoists who carry out People’s War in India, who are the main danger for Indian reaction and Yankee imperialism in South Asia, as ‘armed revisionists’, to deny all that is People’s War in the world, through erasing the class line that separates People’s War, that is, the Military Line of the proletariat, from the bourgeois military line applied by revisionism. What for? To sow capitulation and demoralization in Peru and abroad, to preach their ‘*mass work*’, that is to say their ‘accumulation of forces’, that is to say to serve the bureaucratic road, the old road of elections and parliamentary cretinism.

In the case of India, this rag is at the service of world counter-revolution, of the hegemonist plan and world counter-revolutionary gendarme of Yankee imperialism, because it serves to create public opinion favorable to the warlike action of the armed counter-revolution of reaction and imperialism, mainly Yankee imperialism in India.

#### **4. AN ILLUSTRATIVE CASE: HU FENG**

In the Chinese Revolution there was a very similar case, that of a double-faced counter-revolutionary, Hu Feng and his followers, who like this false ‘representative of the Party’, whom we will hereinafter call the native Hu, were true spokesmen for all counter-revolutionary classes, groups and individuals. Thus, at present, like this double-faced subject.

As a good emulator of the Hu Feng elements, he raises *‘to fight against the armed revisionism of the LOL’* to allude rhetorically to the actions of the People’s War led by the Communist Party, just as when speaking of ‘revisionism’ they allude rhetorically to ‘Maoism’; exactly as the Hu Feng elements in the past spoke of ‘covert feudal forces’ to allude rhetorically to ‘People’s democratic dictatorship led by the proletariat and the Communist Party and based on the worker-peasant alliance’, just as when speaking of ‘mechanicism’ they allude rhetorically to ‘dialectical materialism’.<sup>4</sup>

Many will say how could this happen? As Chairman Mao teaches us:

**‘How do counter-revolutionaries employ their double-dealing tactics? How do they succeed in deceiving us by their false appearances, while furtively doing the things we least expect? All this is a blank to thousands upon thousands of well-intentioned people. On this account, many counter-revolutionaries have wormed their way into our ranks. The eyes of our people are not keen, they are not adept at distinguishing good people from bad types. When people operate in normal conditions, we know how to tell the bad from the good, but we are not adept at seeing through those who operate in unusual conditions. The Hu Feng elements are counter-revolutionaries who put on a disguise to hide their true features and to give a false impression. But since they oppose the revolution, it is impossible for them to cover up their true features entirely.’<sup>5</sup>**

As we have seen in this case, as always, this native Hu uses:

**‘Lu Tien’s suggestion to use offensive tactics for defence [...] Generally, when things are going badly for them, all kinds of representatives of the exploiting classes use offensive tactics as a means of defence in order to survive today and grow tomorrow. Rumours are fabricated out of thin air and lies told point-blank; certain superficial phenomena are seized on for attacking the essence of things; some people are lauded while others are condemned; and matters are distorted and exaggerated**

to ,make a breakthrough at certain points' so as to put us in a difficult position. In short, they are assiduous in studying what tactics to use against us and ,spying out the land' in order to attain their end. Sometimes they ,play possum' and wait for a chance to ,spring a counter-attack'. They have long years of experience in class struggle and are skilful in different forms of struggle, legal and illegal. We revolutionaries must know their tricks and study their tactics in order to defeat them. Never be so bookish and naïve as to treat complex class struggle as a simple matter.”<sup>6</sup>

## **5. TO ANNIHILATE THE PEOPLE'S WAR IS A NECESSITY FOR IMPERIALISM AND REACTION**

To annihilate the People's War is a necessity for imperialism and reaction.

So, now, let us proceed to disembowel his rag, *'AGAINST WIND AND TIDE [...]*”, by showing all his counter-revolutionary wickedness distilled and condensed in the quotation at hand. Beginning by establishing: what is the meaning of all the filthy words of the quote with which he tries to paint all his counter-revolutionary action in red?

Internationally we have already seen that it points against the New Great Wave of the World Revolution, venting all its hatred against the People's War in India and opposes the armed struggles of national liberation that are developing in the backward countries against the imperialist war of aggression and therefore aligns itself with the plan of imperialism. That is the real class character of its misleading call for *'ideological struggle [...]* against revisionism”.

Nationally, it is inscribed in the current campaign of psychological warfare of imperialism and Peruvian reaction, with the collaboration of its revisionist spawn of the 2<sup>nd</sup> ROL (Miriam, Morote, Pantoja, Cox, Nancy, Roldan), or of the 3<sup>rd</sup> ROL (that is, the ROL of José, Alipio, Raúl), as part of the counter-revolutionary war directed by Yankee imperialism as 'low intensity warfare". Current campaign of which the surrender of the miserable traitor 'Artemio" is an important part. Campaign, which calls on *'the terrorist remnants"* to lay down their arms and surrender and to *'disavow Gonzalo Thought and revolutionary violence"*.

What is the Peruvian reaction led by the CIA and headed by the current Humala government after? It seeks to annihilate the People's War, to fulfill its third reactionary task that the present government has assumed; a task that today takes the form of preventing the CPP, in the midst of the People's War, from fulfilling the pending and overdue task of its general reorganization. That is to say, reaction seeks to prevent the Party from solving the problem of its leadership in order to carry the revolution through to the end.

This filthy appeal responds, then, to that renewed reactionary campaign that they are pushing forward with the handing over of the miserable traitor of Huallaga, Artemio, in which they all participate: the American CIA, the government of the fascist, genocidal and country-selling Ollanta Humala, the Catholic Church, the Armed and Police Forces, Antauro Humala, the ROL with Miriam, Morote, etc. and its MOVADef with the rats Crespo and Fajardo, and, as it could not be otherwise, the rats of the ROL headed by José and the others who have usurped the Main Regional Committee (MRC) of the Party and have been setting up since the end of the last century their 'new leadership' — mainly in the zone known as VRAE of the highlands and jungle eyebrow of the MRC — their new '*1<sup>st</sup> Militarized Central Committee*' (which this miserable agent claimed to represent abroad, gave his full and unconditional submission to and to whom he always transmitted to the PPM: '*the greetings of Comrade José, responsible for the Central Committee of the Party*'). On this, it is enough to contrast the history from 1999 to date: before our denunciation of October 2011, this wretch tries to deceive that they were applying the two-line struggle against the ROL of the VRAE, that is why he gave his '*full and unconditional subjection*' to these rats. Who are they trying to deceive with these explanations? When the truth has already come out and, unfortunately, everyone knows that in July 1999, José and his gang, in collusion with the rat Julio of Huallaga, handed over the leadership of the Party to the enemy. It was not only Raúl, but also José himself, Alipio and others. Then, the explanation of this counter-revolutionary, about his so-called '*two-line struggle*', which he claims to have developed with these rats, is nothing more than another incredible traffic and contrary to the most elementary of what is the two-line struggle in the Party.

## **6. FIRMLY ASSUME THE DEFENSE OF THE BASE OF PARTY UNITY!**



Let us go to the main thing, and this is: let us firmly take up the defense of Chairman Gonzalo and Gonzalo Thought, the BPU and the Party experience of more than 31 years of development of our invincible People's War to oppose it to this native Hu who calls for capitulation in Peru and abroad. Let us contrast it with the class truth that is written with the blood of Communists and masses, where it is recorded that with the actions of the guerrilla war the People's War is initiated and developed, that with it the concentric construction of the three instruments is made, with it the New Power is conquered, defended and developed and the masses are incorporated by leaps into the People's War and, therefore, mass work can never be opposed to People's War, much less postpone it or 'diminish' it with the pretext that first 'we must do mass work'.

We reaffirm ourselves in what was established by the Congress:

**'The most substantive and developed part of Gonzalo Thought is found in the Party's General Political Line; this Thought directly sustains, therefore, the line and its five elements, with the point of departure being how it understands and maintains the Programme firmly on course.'**<sup>2</sup>

Therefore, it is necessary to refer to the Party documentation, so that everyone knows how to differentiate, that is, can understand what is the Marxist-Leninist-Maoist, Gonzalo Thought line, and what is the revisionist line and the plan of reaction.

**'The beginnings were modest, almost without modern weapons. Combat was given, it was advanced and it was built from the small to the big and from the weak material and initial fire came the great turbulent fire and mighty roar that grows, sowing revolution and exploding into ever more impetuous People's War.'**

This third milestone lasted from May to December of 1980, resolving the problem of how to initiate the armed struggle, of crossing from the times of peace to the times of war. The militarization of the Party through actions and the masterful Plan of Initiation were key. This was how the new was born: The main form of struggle, the armed struggle and the main form of organization, the detachments and squads. The most outstanding actions in the field were the guerrilla actions of Ayabamba and Aysarca and, in the city, setting fire to the Municipal Building of San Martín. The boycott of the elections in the town

of Chuschi was the action that initiated the beginning of the People's War. This plan was fulfilled, defeating the rightist positions that were saying that the Plan was 'Hoxhaite' and that the actions were centered in the city. These arguments exaggerated appearances with reality and distorted their essence, since reactionary propaganda gave big headlines to the sabotages in the cities and minimized the actions in the countryside. *It is a specificity of the People's War in Peru to make the countryside the main theater of action and the cities a necessary complement.*

[...]

Chairman Mao established the road of surrounding the cities from the countryside, with its heart in the Support Bases. He took into account that the powerful imperialists and their reactionary Chinese allies were entrenched in the main cities, and if the revolution refused to capitulate and wanted to persevere in the struggle it had to convert the backwards rural zones into advanced and solid Support Bases, into great military, political, economic and cultural bulwarks of the revolution to fight against the fierce enemy that was assaulting the rural zones using the cities, and to carry the revolution forward step by step to a complete victory through a protracted war.

Based on this Maoist thesis, Chairman Gonzalo has established the carrying forward of a Unified People's War where the countryside is the main theater of armed actions. Since in our country we have an immense majority of peasant masses, that is where we must build the Support Bases. [...] Furthermore, Chairman Gonzalo specifies that in the cities armed actions should be carried forward as a complement, since international experience, as well as our own, demonstrates that this is feasible.

[...]

The Support Bases are the strategic bases which the guerrilla forces rely on to fulfill their strategic tasks and to achieve the objective of preserving and increasing their forces as well as annihilating and throwing back the enemy. Without such strategic Bases there would be nothing to base ourselves on to carry out any one of our strategic tasks and to reach the war's objective.

Chairman Mao expounded three reasons for the creation of Support Bases: To have armed forces, to defeat the enemy and to

mobilize the masses. These were specified in our People's War in 1982, by applying the Plan of Deployment of the guerrilla war in the part 'Strike the enemy', aiming at destroying the old feudal relations of production. Police posts were assaulted, selective annihilation of feudal landlord Power was applied, and the police forces abandoned the countryside and were regrouped in the provincial capitals. The authorities of the old Power massively resigned which created a Power vacuum, while tens of thousands were mobilized. It is in these conditions that the Support Bases emerged and were specified in the Clandestine People's Committees. Therefore, it is wrong to take the Chinese experience dogmatically since if the conditions were given and principles were in effect, we would have had sufficient reason to build the Support Bases. To agree upon this implied a struggle against rightism which argued that we had not defeated large enemy forces, when the problem was that the enemy forces had abandoned the countryside as a consequence of the rout of their political and military plans.

Chairman Gonzalo has established a *system of Support Bases* surrounded by guerrilla zones, operational zones and points of action taking into account the political and social conditions, the tradition of struggle, the geographical characteristics and the development of the Party, the Army and of the masses.

*It is fundamental to support the validity of the road of surrounding the cities from the countryside and its heart, the Support Bases, because with only wandering guerrillas of insurrection the PGA would not have the Support Bases as a rearguard that sustains it, nor would the new Power be built. We are totally against focism."*

'Since 1983, the political strategy of the Great Plan of Conquering Bases was completed through two campaigns of defending, developing and building Parts 1 and 2, and the Plan for the Great Leap with its four campaigns up to December 1986, show us the advance of the People's War, that we are solidly linked to the masses, contrary to everything they say, since the facts belie them irrefutably. The People's War has conquered an area that extends itself through the Highlands, the Jungle and the Coast, marching vigorously and strong, building the new and opening what is to be. The Support Bases which are the core of the

**road of surrounding the cities from the countryside have already been conquered.”<sup>8</sup>**

All the above quotations are extracts from the Military Line of the CPP, center of the General Political Line of the Party, sanctioned by the 1<sup>st</sup> Congress in 1988.

Let them not come to us with stories:

**‘Campaigns of ,encirclement and annihilation’ and the counter-campaigns, the main form of the People’s War. It is a law that the counter-revolution, in order to crush the revolution unleashes campaigns of ,encirclement and annihilation’ against each unit of the People’s Guerrilla Army or against the Support Bases. The operations of the People’s Guerrilla Army adopt the form of counter-campaigns and Chairman Mao has established nine steps to crush a campaign of ,encirclement and annihilation’.”<sup>2</sup>**

The plan of reaction is to make us fall into the trap of counterposing ‘mass work’ to the People’s War, this is what all the rag published on the usurped *Red Sun* page is for. We see some excerpts from the Mass Line of the Party to unmask this plan:

**‘We should organize the masses with arms in hand because they clamor to organize the rebellion. As such, we must apply People’s War which is the main form of struggle, and organize the masses for the seizure of Power led by the Party.**

[...]

**[Chairman Gonzalo] differentiates from those positions that today are based on ,the accumulation of forces’, which propose parsimoniously accumulating the masses by way of the so-called ,democratic spaces’ or the use of legality. Such an accumulation of forces doesn’t correspond to the current moment of the international and national class struggle, it doesn’t fit in the type of democratic revolution we are unfolding and which shall have other characteristics within the socialist revolution, since we are living in a revolutionary situation of unequal development in the world. He is opposed to and condemns the opportunist positions of making the masses tail after the big bourgeoisie, either on an electoral path or by armed actions under the command of a superpower or power.**

[...]

**Organize the masses so that they can go beyond what is permitted by the existing legal order, so that they struggle to destroy the old order and not to maintain it. This is accomplished by use of the Three Instruments of the Revolution: The Party where the few converge, the Army with more participants, and New State-Front which is the base which progressively accumulates the masses through leaps. In the countryside this is achieved through People's Committees and in the cities through the People's Revolutionary Defense Movement. In this way the tradition of electoral fronts, which the revisionists and opportunists apply to channel the struggle of the peasantry and to divert the masses in the cities from not seizing power through war, is destroyed.**

**To center on political power also demands the organization of the masses in diverse new forms of struggle, because war imposes changes on the struggle and organization of the masses.”<sup>10</sup>**

Who are they trying to confuse? Well, we have a main form of struggle, the People's War, and a main form of organization, the Army, and the mass work is carried out through the Army, all this is developed through the military plans of the People's War which are embodied in campaigns and armed actions with which the great mobilization of the masses is generated which then have to be incorporated into the Party, the Army and the Front/New Power. The People's War is carried out throughout the breadth and length of our geography, without excluding any geographical region — and not as this infiltrator says *'but not in the jungle'*. As we read in the quotations from our Military Line, actions are carried out not only in the countryside, but also in the city.

For that reason, we mark with fire everything that this native Hu repeatedly says, it is pure reactionary hoax. In the face of it, what we must do is denounce it, smash this reactionary hoax that uses the name of the Party, of its generated organization and of the *Red Sun* magazine to serve the plan of reaction to prevent the general reorganization of the Party, to liquidate the PPM and to use the prestige of the Party and the People's War, to oppose and stifle the struggle of the Communist Parties and revolutionary organizations to advance in the process of coordination to crush and overcome the situation in which the RIM finds itself due to the nefarious action of the new revisionism converging with the action of imperialism and Peruvian reaction. Opposing the efforts of the Communist Parties and revolutionary

organizations, using as a battle flag the black reactionary banner of opposing a People's War against another People's War: as when this subject says that *'to support the People's War in India is to isolate the People's War in Peru'*.

Against all this reactionary hoax, what corresponds is to continue the task of the general reorganization of the CPP in the midst of the People's War to carry it forward victoriously until the conquest of power in the entire country and culminate the democratic revolution, under the Great Leadership of Chairman Gonzalo and Gonzalo Thought, which is the center of Party unification and the guarantee of triumph that leads us to Communism. For us in particular to continue with the construction at all levels, today focusing on the reorganization of the PPM, fulfilling our three established tasks and the two campaigns, mainly the defense of our Great Leadership as the key link that allows us to pull everything.

The reaction, through this rag, tries to call us not to fulfill our established tasks to serve the People's War, to continue developing the plans and campaigns of the Party in Peru and abroad. Because its plan and its campaign aim at spreading revisionism and capitulation, that is what corresponds to reaction and imperialism, they are the ones who have always promoted and engendered revisionism and treason applying the principle that strength is taken from within. That is why this wretch cannot present on behalf of his 'PPM' and his 'Central Committee' any Marxist-Leninist-Maoist, Gonzalo Thought plan and campaign, he cannot present any Party summary, much less of the two-line struggle that now after 12 years they say they have developed with their 'responsible José', that is why they cannot even characterize the current government, nor its reactionary tasks, that is to say, no political foundation of the Party situation, of the national and international situation, that is to say, no political foundation, nothing about the two-line struggle and the class struggle in the country and in the world, but only 'brushstrokes' about it that any 'light leftist' could say. He only repeats the same thing for 12 years about 'mass work' and 'actions', but nobody believes that story anymore, no matter how much he — like the rat José — tries to present them as 'Maoism' with quotes that denaturalize them to try to justify the unjustifiable from the Marxist-Leninist-Maoist, Gonzalo Thought, mainly Gonzalo Thought position, method and world outlook.

For us, the ideological struggle is inseparable from the political struggle, from the concentric construction of the three instruments and the

work of the masses is part of the concentric construction of the three instruments of the revolution and the militarization of the Party in the midst of the People's War, that is, the mass work is within and for the People's War and is done through the Army.

We recall the great principle of construction: On the ideological-political base, to simultaneously construct the organizational, in the midst of the class struggle and the two-line struggle, all within and serving the People's War for the conquest of power. In the 2011 document we state:

**‘The seriousness of the situation in the two-line struggle has led to a situation where organizational problems have become absolutely subordinate; the main thing at this point in the struggle must be the ideological, because what is at stake is the color of the Party as a whole. Without unity of understanding, without unity of ideology, there is no BPU. It is more necessary than ever to grasp Gonzalo Thought to solve new problems.’<sup>11</sup>**

But that, is something fundamentally different, to separate the ideological struggle from the political struggle, from the problem of power for the class, because for our ideology to show all its transforming power it has to be applied to a reality, to a concrete situation, to the Peruvian Revolution; in our case, to solve the problems presented to the Party and the revolution. And that is politics, as Chairman Gonzalo tells us, the masses need politics, because only with it can we respond to their needs, if it is not applied — as Chairman Gonzalo tells us — it can only shine but it does not serve as the all-powerful weapon that it is, the most powerful weapon in the world in the hands of the proletariat and the people. It is with it that they will solve their main historical need, to make the revolution.

## **7. WHAT IS THE SINISTER INTENTION BEHIND THIS CALL TO ONLY ‘DEVELOP IDEOLOGICAL STRUGGLE’?**

Logically they are aiming at capitulation through telling us that abroad ‘line alone is enough’, that is a rotten revisionist line of reactionary character. What they seek is to depoliticize our ideology so that it serves the plan of reaction and imperialism: to separate ideology from politics, pretending that it is not put into practice, that abroad the established tasks are fulfilled and that in Peru only ‘mass work’ is done, repeating the old revisionist

nonsense of more than 80 years of ‘accumulation of forces’; this is what the wretch has been propagating here through his ‘directives’ for 12 years.

We reject this reactionary monstrosity that says that what corresponds here is to carry out ‘ideological struggle’ simply, because for us it is strictly linked to the political struggle and to the construction in the midst of the People’s War, to serve its development and triumph. Ideology cannot operate independently, class is strictly political, because it is thought and transforming action.

With this monstrosity that calls only ‘ideological struggle’, it is intended to take away all practical sense from the ideological struggle, which for us is centered on the defense of Chairman Gonzalo’s Great Leadership.

This reactionary plan is embodied in concrete, as always, on the grounds of ‘new circumstances’; however it is presented, in essence it is ‘there are no conditions to continue the People’s War’. According to this reactionary plan, it is only necessary to carry out some actions (to deceive the unwary, but even then they do not even speak of any concrete ones, because their ‘Central Committee’ is nothing more than a reactionary figment) and to focus on ‘mass work’. Round! That is José’s ROL that reaction promotes.

Look at the development of this ROL for more than 12 years: they usurp a Party Committee and focus on one zone and only carry out actions to maintain themselves and do ‘mass work’ to defend fiefdoms, but without constructing the conquest of power in the entire country, because they are not for the revolution, for power for the class, for the Party, but for personal power.

That is why the agent who has usurped the *Red Suntries* to paint himself as a defender of the Great Leadership and of Gonzalo Thought, but in the pure style of the rat José says ‘as in China’, ‘as Chairman Mao says’, trying to paint himself as a Maoist, to oppose Chairman Mao against Chairman Mao by denying Gonzalo Thought which is the creative application of Marxism-Leninism-Maoism.

It is therefore a ‘Marxism of eavesdropping’, of ‘hearsay’, as befits its reactionary nature. Since the end of the last century it has been transmitting the directives of the rat José and his fiefdom as directives of the Central Committee, intermingled in recent years with Cubanist positions and those of *Red Fatherland* and interspersed with what they catch in the blogs of the



Internet and what the informers of reaction catch in their prison eavesdropping and the documentation that has fallen into the hands of reaction.

That is why in all their documents — no matter how much they put our cheers and slogans — in all their content, they only exhume those positions contrary to Marxism-Leninism-Maoism, Gonzalo Thought.

As we have already pointed out above, the plan of reaction has been to use the *Red Sun* to cover-up the capture of the Party Committees one after the other by José. Because of this, in the *Red Sun* eclectic positions have been being published, taking a leap starting in 2005, which come from the ‘*new leadership of the Party*’ — which is none other than José himself. The call for a ‘*new Congress*’ is framed within these and it was the Left of the apparatus abroad that imposed that nothing be published on the matter — without failing to stress that a new Congress is only possible on the basis of the BPU sanctioned by the 1<sup>st</sup> Congress.

## **8. CELEBRATE THE 20<sup>TH</sup> ANNIVERSARY OF CHAIRMAN GONZALO’S SPEECH WHICH SHINES VICTORIOUSLY AND POWERFULLY BEFORE THE WORLD AS A COMBAT WEAPON!**

In the present document we have demonstrated, contrasting the black position of the counter-revolutionary agent who has usurped the name of the Party, the PPM and the *Red Sun* with the Marxist-Leninist-Maoist, Gonzalo Thought position of our Party. For this reason we have had to resort to long quotations. Lenin taught us that complicated issues must be re-studied several times in order to understand them well and to be able to firmly take the just and correct position and defend it under all circumstances. Therefore, the comrades and colleagues need to re-study the document of October 2011 and the present one; in this case there has been so much confusion due to the disinformation of the enemy, so much repercussion of their psychological warfare. We must take a firm stand for our Great Leadership, our ideology, our BPU, our Party and the People’s War and smash the reactionary plan. An indispensable part of this is to develop our revolutionary practice in new forms, as part of and in the service of the People’s War. We call on all comrades and colleagues to celebrate next May 1<sup>st</sup>, the Day of the International Proletariat, and May 17<sup>th</sup> (anniversary of ILA-80) with actions that serve to develop the two unified campaigns. Furthermore, we call upon all the forces that were mobilized by the campaign to defend the life of

Chairman Gonzalo, as well as the new forces that have emerged and those who are for Communism, to celebrate the 20<sup>th</sup> anniversary of Chairman Gonzalo's speech which shines victoriously and powerfully before the world as a weapon of combat. The Southern Command announced and understood its projection in the area. Its mission and vision seemed overblown, to such an extent that it claimed to be the leading organization among existing agencies to ensure 'security, stability and prosperity throughout the Americas'.

This new Southern Command strategy reinforced the military component of U.S. international policy toward the area. For example, between 1997 and 2007, total U.S. military and police assistance to the region was

approximately \$7.300.000.000. From 2005 to 2007, four countries in the region were among the fifteen largest recipients of U.S. security assistance (Colombia, fifth; Bolivia, eighth; Peru, tenth; and Mexico, twelfth). Between 1998 and 2008, the total number of Latin American military personnel trained in the United States reached 141.430.

In this regard, the approval of the Merida Initiative for Mexico and Central America in June 2008 and the new deployment of the 4<sup>th</sup> Fleet. As of July 1<sup>st</sup> of that year, they took place in the context of a greater extension of U.S. military power in the region and in the context of an inflation of tasks assigned to the armed forces after September 11<sup>th</sup>.

In turn, the agreement forged in 2009 between Washington and Bogotá for the use of Colombian bases was part of this trend, but a more ambitious ingredient was added ... the qualitative leap that the commitment between Colombia and the United States signified became evident. In essence, the agreement was presented in Bogotá as a necessary continuation of the fight against drug trafficking and terrorism, and in Washington it was presented as an indispensable replacement of the Manta base in Ecuador, which the United States was to leave in November, as locations to carry out ‘contingent operations, logistics and training’ and as a bridge to expand contact between the Southern Command and the recently created African Command, according to the specific language of the Pentagon documents.

But now we are witnessing a new dimension of the ‘war on drugs’: it serves the Southern Command to have a broader scope, and the military to continue unperturbed the strategy of U.S. primacy that was drawn at the beginning of the Post-Cold War and that has not yet been modified.” (Tokatlian, Juan Gabriel (2010): La ‘guerra antidrogas’ y el Comando Sur. ## The Revolutionary Situation Develops Powerfully in Peru and the World!

The revolutionary situation is developing vigorously in Peru and in the world. The objective conditions are every day more favorable for the realization of a great leap in the development of the strategic offensive of the proletarian world revolution, the new great wave of the same is developing more and more powerfully. The crisis of imperialism demonstrates, once again, before the peoples of the world that it is incompatible with the progress of humanity. Revolution expresses itself more sharply as the main historical and political trend as a manifestation of the overwhelming necessity of matter and, as part of it, of human life itself. Like all reactionaries throughout the millennia of private property, today’s imperialists try to oppose the revolution with every possible means. They are already well known, ranging from horrendous genocides to petty intrigues. No method that serves their counterrevolutionary ends is foreign to them. Their main point of attack has always been that which at the moment most serves to disrupt the revolution, to hinder its advance and unravel it until it can — for a moment — lead it to defeat, which for the new will always be temporary. So it was yesterday, so it is today and so it will always be. For this reason, to rebel against the reactionaries will always be the only justified and correct thing to do for those of us who are for the revolution. Any other idea does not correspond to our class conception, does not correspond to Marxism-Leninism-Maoism, Gonzalo thought, does not correspond to our philosophy, does not correspond to the principle of going against the current. Therefore, only

communists who embody this principle can be considered as strong trees that resist the strongest storms. Thus, forging ourselves in Marxism-Leninism-Maoism, Gonzalo thought, mainly Gonzalo thought, demands to advance in such a way; marching against the current.

Based on the above, we have the necessary foundation to understand the struggle that we are developing abroad as part of the struggle for the reorganization of the Communist Party of Peru. For this reason, it is with full optimism and with the absolute conviction of the justness of our cause, that at present we continue developing the struggle against revisionism, against the two Right-opportunist lines, both revisionist and capitulationist, and, as part of the same phenomenon, against the reactionary aberration that from a web page abroad continues trying to generate confusion and dis cohesion among the communists, revolutionaries and masses of the world who see in the people's war in Peru, correctly, their torch.

## **1. TWO TWIN DOCUMENTS**

The miserable reactionary agent who presents himself as 'representative of the Party abroad' and is usurping the website *Red Sun*, has published in said medium a statement entitled: 'Combat Humala's Even More Exploiting, Genocidal and Pro-Yankee Imperialist Government, Developing More People's War!', June 2012, the same that it attributes to a supposed 'Central Committee of the Communist Party of Peru', drafted trying to simulate the language and style of the Party, but which has only achieved a badly made, reactionary mimicry, eyesore of Party documentation, truly counterrevolutionary and grotesque as we are going to demonstrate and which resembles like two drops of water another statement, published by the revisionist and capitulationist Right-opportunist line, that of the 'peace letters' (the 2<sup>nd</sup> Right-opportunist line), titled: 'Long Live the 1<sup>st</sup> of May, Day of the International Proletariat!', Peru, May 1<sup>st</sup>, 2012, which we mark by fire and denounce as a perverse counterrevolutionary hoax to unravel the Communist Party of Peru and the people's war. For this we have to disembowel it part by part:

## **2. WHAT IS THE CONCRETE POLITICAL GOAL PURSUED WITH THIS NEW STATEMENT BY A NON-EXISTING 'CENTRAL COMMITTEE'?**

Let us start with the concrete fact: this ‘statement’ has been published by the counterrevolutionary subject that we have been denouncing, attributing it to an alleged ‘Central Committee of the Communist Party of Peru’, which only issues its communications through this means and abroad. In this it is said that this *‘leads our revolution in Peru, preparing and developing the days of struggle’* of the masses throughout Peru, but this reactionary monstrosity only exists in cyberspace, it does not even exist on paper and all that is written in the statement that we are denouncing is contrary from beginning to end to Gonzalo thought and to the basis of Party unity. This is the greatest proof that it is not authentic and we refer to it as the best revealing mirror of such counterrevolutionary hoax against the Communist Party of Peru and the people’s war.

Starting from this concrete fact, the counterrevolutionary agent, who in our previous document (April 2012) we have called the native Hu Feng and his digitalizer, attributing to their counterrevolutionary monstrosity the ‘ultra-secret directorship’ of the revolution and the struggle of the masses, supposing that they are no longer obliged to prove the existence of this counterrevolutionary spawn; they pretend to traffic with revolutionary secrecy so that, later, wielding this deception as the only proof of its existence, they can use it to continue presenting themselves as the ‘authentic representative of the Party’ and continue usurping the letterhead of the ‘Peru People’s Movement’ and the website usurped from the Party. Abroad it is limited to its ‘ideological struggle’ that it furiously carries out on the Internet against the communist parties that lead people’s wars such as the Communist Party of India (Maoist). In Peru they are miraculously nowhere to be found. This new ‘statement’ is also a desperate and useless attempt to counter our two previous public documents, of October, 2011, and April of this year, in which we have denounced the reactionary hoax usurping the name of the Party and its organizations.

Therefore, where is the native Hu Feng aiming at with those spawns? He aims to disrupt the Party and the people’s war, by continuing to sow more confusion and distrust in the Party work, denying the need for the general reorganization of the Communist Party of Peru in the midst of the people’s war and the struggle to the death against revisionism inside and outside the Party. The action of this miserable agent of the enemy directly serves the third reactionary task; the same one which pursues the annihilation of the

people's war through the annihilation of the Party, which today is concretized in preventing the communists of the country from fulfilling the pending task of reorganization. This subject is impelled to continue with the reactionary hoax of 'the only representative of the ,Central Committee' abroad" to cover up his counterrevolutionary actions, which he has developed since the end of the '90s of the last century.

Hence the need to contrast what this 'statement' says and what we have just said with the concrete facts, with the material reality, with the present situation in the light of Marxism-Leninism-Maoism, Gonzalo thought, mainly Gonzalo thought and the basis of Party unity, in order to break it apart.

### **3. CONTRASTING THE 'STATEMENT' WITH THE BASIS OF PARTY UNITY**

The statement of the hoax says: that this 'party', which they have fabricated and which the counterrevolutionary subject 'represents' abroad, *'leads our revolution in Peru, preparing and developing the days of struggle with the proletariat, peasantry and students throughout the length and breadth of the country [...] we assume it [...]crushing revisionist lines within and outside our ranks. The party has been advancing in resolving the inflection of our vigorous and ardent people's war, taking Gonzalo thought to solve new problems with optimism at the top and the inexhaustible confidence in the masses'*<sup>1</sup>. Which they will specify paragraphs below, when, referring to the national situation, they write to which struggles they refer: *'[...] Cajamarca and Espinar [...]'* (Aha! It is not only air struggles.) *'The teachers on June 13<sup>th</sup> began their days of struggle with a resounding strike showing greater organization and struggle against revisionism in their ranks [...]'*, etc.

In this quotation and its complement is the central object of his sleepless nights and therefore we have to focus on unpicking contrasting it with Gonzalo thought and the basis of Party unity, because the story in his homework is long. So, let's get to the point and without ado.

If they say that this supposed 'Central Committee of the Communist Party of Peru' *'leads our revolution in Peru'*, what is the first thing that jumps out in the whole 'statement' published by the native Hu? That apart from the enumeration of some data there is no analysis and synthesis that



could correspond to Gonzalo thought and the basis of Party unity. Starting from the fact that there is nowhere the characterization of Peruvian society according to this, that is to say as semi-feudal and semi-colonial, subjected to imperialism, mainly U.S., where a bureaucratic capitalism develops. They talk about everything in the above-mentioned ‘statement’, they mention semi-feudalism but in the style of the Right-opportunist line with the ‘peace letters’ or ‘peace agreement’. Thus, the ‘statement’ refers to the new concentration of land, etc., but without seeing it as part of the process of evolution of semi-feudalism and separated from its basic characteristics of big landownership and serfdom, granting the big landownerships that are being generated with the new concentration of land a capitalist character when it qualifies them as property of the ‘national bourgeoisie’ with these words:

*‘[...] the formation of new large estates for agro-export [...] Here in Peru the companies that concentrate the largest number of lands are the Gloria groups, the Romero, Maple, Damper, Agrokasa, Oviedo, economic groups of the national bourgeoisie that develop linked to Yankee imperialism. This government has been serving the big imperialist capital and is aligned to the great dispossession of lands that occur in the world, has the same line and objective. For this, as imperialism’s foreman [...] the development of bureaucratic capitalism that imperialism develops by dispossessing land on the coast for the so-called agro-export, in the highlands to imperialist mining companies [...] in the jungle [...]’<sup>2</sup>*

According to the quote, the government has been serving these groups of the ‘national bourgeoisie’ ‘dispossessing lands’; it is clear there, that is why we have underlined it. So according to this the Humala government would at least also represent the national bourgeoisie, that is why he says that the government is doing ‘populist politics’ following the bourgeois political scientists who use this denomination as a synonym of a ‘nationalist politics’, that is to say, they want to create a whole confusion for us. But any Party militant knows that this is not the reality, that these groups belong to the big comprador bourgeoisie and the landowners. The big bourgeoisie is monopolist like its master, imperialism, its groups do not belong therefore to the middle or national bourgeoisie, so they try to confuse the national bourgeoisie with the big bourgeoisie to go after this faction as ‘part of the united front’, trying to take the Party history back to before 1965, as we will see later.

They hide the semi-feudal character of the relations of production of these farms and in the rest of the country there are no landowners for them, the landowners do not appear anywhere and the State which represents and defends that society is, for them, only ‘old State’, that is why they are careful not to mention its class character. That for the Party as it is established is: landlord-bureaucratic. Therefore, the only guilty party for the present situation of the country are not the landowners and the big bourgeoisie but only the ‘*economic groups of the national bourgeoisie*’ and U.S. imperialism. The three mountains that oppress and exploit the people are nowhere to be found. Just like the Right-opportunist line of the ‘peace letters’, which says in its annotated statement: ‘*Current Peruvian society is capitalist, dependent on imperialism and with semi-feudal remnants subsisting.*’<sup>3</sup>

So if they speak only of the old State, they are denying that the old State is the system of organized violence of Peruvian society, of this class society, of the dictatorship of landowners and big bourgeoisie, then, as Chairman Gonzalo teaches us:

**‘[...] in this way what is intended is to separate politics from society, and that is not true; what is interesting is that there are contradictions between the factions of the big bourgeoisie, in which there are even groups; it is good to keep in mind that there are interests of their lackeys who ride over the masses — the opportunists and revisionists — who also have unity of general interests but difference of specific interests because if not how do they ride over the masses? has it worsened or not? Of course, these contradictions have worsened, are we seeing it or not?’<sup>4</sup>**

This is a clear and piercing denunciation by Chairman Gonzalo against the monstrosity that tries to prevent us from seeing the development of these contradictions and how the opportunists and revisionists who want to cover our eyes by deceiving us that they are leading these struggles in ‘[...] *Cajamarca and Espinar [...]*’, saying ‘[...] *are riding on the struggle of the masses [...]* The teachers [...] *showing greater organization and struggle against revisionism in their ranks [...]*’, this is false, as we are demonstrating here, these phonies are against the struggles of the masses — like the ones they mention — developing independently, that is why they try to confuse a faction of the big bourgeoisie with the national bourgeoisie as we have

seen above, because as lackeys they do not want the Party to lead the united front of the revolution to serve the development of the people's war.

#### **4. THE 'STATEMENT' SHAMELESSLY ATTACKS CHAIRMAN GONZALO AND GONZALO THOUGHT WHILE CLAIMING TO DEFEND THEM**

Then, in this 'statement' by the reactionary hoax that usurps the name of the Party, they change the character of society, of the State and, therefore, the targets of the revolution and with it also — like the Right-opportunist line — they change the character of the revolution and the road of encircling the cities from the countryside, for these the countryside is complementary and the city is main, the people's war ceases to be the main form of struggle and as main form of struggle it passes to *'days of struggle'* of the masses in the cities. They also forget the oppression and exploitation by the other imperialist powers in collusion and contention over our country and especially China.

For that reason, the he only presents the government as *'imperialism's foreman'* or at the service of those *'groups of the national bourgeoisie'* or as *'Humala's even more exploiting, genocidal and pro-Yankee imperialist government'*. That is how slippery they are, seeking not to be caught. For them, he is not a representative of the landowners and the big bourgeoisie, at the service of imperialism, but only a *'foreman'* and *'pro-Yankee imperialism'*. Nor do they say anything about how the current process of reactionarization of the old State is taking place, how this government continues with the task of restructuring the old State with blood and fire, starting with the Executive subject to the genocidal and country-selling Army as the highest expression of the reactionarization of the old State; They do not say, either, if this takes place with presidential absolutism or fascism; therefore, the regime, for them is not fascist, genocidal and country-out, which is shown as the most unbridledly pro-imperialist of our history; for the 'statement' it is only *'Humala's even more exploiting, genocidal and pro-Yankee imperialist government'* and also *'populist politics'*. They pretend not to see the process of restructuring the old State as a whole and the role of the presidents and regional governments, corporate bodies, as buffers of the struggle of the masses, on the contrary they extol them as we saw in our previous document; but even for bourgeois scholars the role of the regional governments is clear,

thus an expert from the other hill in an interview granted to the magazine *¿Qué Hacer?* No. 186, Lima April-June 2012, Un mundo dividido: Lima y provincias / Una entrevista a Eduardo Ballón E. / SANCHEZ LEON, Abelardo says: *‘It is very clear that in many of the most visible conflicts in the country the regional governments have played an important role of channeling and negotiation.’* As we are currently seeing in Cajamarca or in Tacna and in all the other regions, and it occurs in the midst of acute struggle to then collude as Chairman Gonzalo teaches us. The reactionary monstrosity — as can be seen — does not matter much, but since it usurps the name of the Communist Party of Peru it must be blown up showing all its reactionary evil.

That is why we should take firm hold of Chairman Gonzalo to stone this monstrosity. Chairman Gonzalo tells us:

**‘In essence, we cannot correctly understand a democratic revolution such as ours if we do not see the sustenance, the base, the semi-feudal background that persists because then we would not understand the problem of the land and consequently we would not understand the problem of the peasantry, and the peasantry is the main force of the Peruvian revolution, it is the massive and fundamental, basic force of the people’s war and of the People’s Guerrilla Army.’**

He also says:

**‘Not to understand the peasant problem, the land problem, the problem of the semi-feudal relations is not to understand Peru, it is not to understand the Peruvian revolution, it is not to be rooted in its democratic character. We have to see the three mountains: semi-feudalism, bureaucratic capitalism and imperialism. And we have to unmask the penetration and the greater imperialist domination, mainly U.S., in Peru. That is, mainly it does not say only, because otherwise we do not see the sectors of the big bourgeoisie according to the imperialism they defend.’<sup>5</sup>**

If they do not see the three mountains how are they going to see the main thing of the process of demolition of the old society by the people’s war; the key question of the demolition of the old society and the old State, is how we are destroying old relations of production and how we are introducing new ones where we exercise power, the new power, where we have the People’s Republic of New Democracy. And it is established that this new

power is established and maintained as soon as the Party with the army develops people's war, because without the army, how can the power be maintained? There is no new power without the Army.

## **5. THE AUTHORS OF THE MONSTROSITY SHOW BY THEIR OWN HAND THAT THEY ARE NOT MARXISTS BUT REACTIONARY AGENTS**

We have shown how these wretches, with their own words written in their own handwriting, are not Marxists at all and everything they prattle on about is of reactionary essence and as such it is convenient for them to repeat what the Right-opportunist line of the 'peace accords' spreads. Who are they going to be able to deceive that they are leading the revolution in the country?! If they do not even mention what is the contradiction that has become the main one at present. We are firmly convinced that, in order to lead and conduct the people's war as Chairman Mao and Chairman Gonzalo teach us, it is necessary to see **'the changes in the contradiction'** as for example when a change of contradiction took place in China which became the contradiction between the Chinese nation and Japanese imperialism. Using this example, Chairman Gonzalo tells us:

**'One may ask: But we are not precisely in this contradiction? It is true, our main contradiction is between the people's masses and semi-feudalism, that is the main one, but there are three contradictions, the other is against bureaucratic capitalism and against imperialism, they are three contradictions that occur in the country. Although that is the main one, we have to think that the development of the people's war, the problem of the conquest of power in the whole country necessarily leads to a clash with imperialism.'**<sup>6</sup>

This does not matter to the authors of this 'statement', and they say that they *'lead the revolution'*, but they do not determine which is the contradiction that has become the main one in the present situation of the development of the people's war and the counterrevolutionary war, because they are two hills that are in conflict. And, with this, what type of war is developing, whether agrarian war or national war. All this does not fit in their heads because of their condition of reactionary swindlers in their eagerness to present themselves as the 'Central Committee of the Communist Party of Peru'.

But every militant, every revolutionary knows that this is key. In this regard, Chairman Gonzalo tells us:

**‘Look at what Chairman Mao says: The only differences between them, between a civil war and a national war, are the same that exist between a war waged by the Communist Party alone and a war waged jointly by the Kuomintang and the Communist Party (the war of resistance against Japan).’** They are revolutionary wars but they have differences, some are conducted by the Party alone, we are unfolding as **‘Party alone’** in the war, so it is in the agrarian war. The civil war **‘unfolds in a country in which the people go against the existing regime to destroy the old power and imperialism does not act directly’**<sup>7</sup>. And when imperialism intervenes directly it is a national war. And this is important because in the face of this, the breadth of the class front will be defined and therefore what kind of opportunism it is, Right or ‘Left’ (that is why these rats call the Right-opportunist line of the rat José in the VRAEM a ‘Left’-opportunist line”, those who do not fight against the landowners and the big bourgeoisie and see everything as unity, with the pretext that they are already developing a war of national resistance). So if they do not start from clearly establishing all these questions, how will they be able to direct the Party itself, which as we know is advancing and developing in a hard two-line struggle between Marxism and revisionism, between Left and Right, how will they be able to direct the concentric construction and militarization of the Party and of the other instruments of the revolution without correctly carrying out this two-line struggle, without this two-line struggle, how will they be able to approve, apply and evaluate the plans, etc.? Moreover: if they change the objective of the democratic revolution, how will they be able to lead the democratic revolution? Fascinating! Thus they dropped the hoax of their whole ‘statement’, let us see in this respect in the ‘statement’ the following quote: *‘Only the democratic revolution led by the worker-peasant alliance under a proletarian leadership which is concretized in the Party with people’s war will be able to accomplish in liquidating semi-feudalism and establishing a socialist republic.’*<sup>8</sup>

And the Right-opportunist line goes even more directly to the same thing pointing out the character of the revolution in our country to justify developing everything peacefully through mass struggle as the *‘days of struggle’* at the time of the ‘statement’, thus says the Right-opportunist line

in its already mentioned statement of May, 2012: *‘The need to forge the lever to transform the world serving communism, concretizing in our country the socialist revolution.’*

What Chairman Gonzalo tells us against these reactionaries and revisionists in cahoots:

**‘It is the war that decides, everything is subordinated to the interests of the war, why? Because that war points to the central task, to the central task of everything which is power, to the conquest of power which will resolve all questions, and furthermore war is the main way to resolve the higher contradictions, everything is subordinated to it, that is so, therefore when four classes unite the interests of the four are subordinated to maintaining the war, but to maintain the war implies to maintain it with its objectives, and the objective of the war is to conquer power to culminate the democratic revolution and to continue it as socialist, that is the problem, therefore we cannot renounce to the interest of the class neither to its objectives nor to its goals, that is why Chairman Mao tells us: *‘But the existence of classes and class struggle is a reality: and those who deny the reality of class struggle are wrong. Any theory that attempts to deny the existence of class struggle is completely wrong. We do not deny the class struggle, but we readjust it.’*’<sup>9</sup>**

Of course, we start from the fact that it is a front of classes where these contend and fight, but they must put aside their interests serving the common objective, of the war; for example, we are communists, our objective is communism, but now why do we fight? For the conquest of power and to make a People’s Republic of Peru, that is what we want, the People’s Republic, that is to say, to culminate the democratic revolution, and that is what the peasantry wants, that is what the small bourgeoisie wants, that is what the national bourgeoisie wants, that is their interest, but we do not renounce the class struggle, we persist and form and remain independent ideologically and organically to then continue and lead, and as that interest is the only one that saves all humanity, then we arm and manage everything in function of that being fulfilled, because otherwise the other classes cannot be emancipated, that is how we act, but we give each stage its objective, that is why the President says:

**‘We do not renounce the class struggle, what we do is readjust according to the objectives.’**<sup>10</sup>

Then when they change the People's Republic of Peru to 'Socialist Republic' following what was said by the Right-opportunist line of the 'peace letters' in their May statement, these are against maintaining the war, because maintaining the war implies maintaining it with its objectives and this is to conquer power to culminate the democratic revolution and continue it as socialist, then if the objective for which we now fight is changed from 'for the conquest of power and to make a People's Republic of Peru' to 'culminate the democratic revolution', it goes against reality, against the class struggle, against the front of the democratic revolution, it seeks to isolate the proletariat from its main ally, the peasantry, and the other classes, and for what? So that the revolution does not go forward, that is trotskyism, that is the Right-opportunist line with a 'Left' veneer. But what else is behind it, if we add that they separate mass work with people's war, we have clear that this is accumulation of forces of revisionism to tail the electoral road, this is black electoral frontism opposed to people's war.

As we have already referred to, in the quote of this 'statement' on 'the economic groups' of the big bourgeoisie, of the comprador faction, and of the landowners, these wretches call them literally: *'economic groups of the national bourgeoisie'*. This is not a simple change; if one sees the history of the Party, Chairman Gonzalo tells us:

**'All along it has been ,to unite with the national bourgeoisie', in the end it was to put oneself on the tail of the big bourgeoisie, of one of its factions, that is the history of the Party, that is the history of Peru, until the demarcation was made in 1965, that was the predominant criterion; thus ,they denied the policy of independence and autonomy in the united front', is that not the policy they put forward in the frontism? That is the tradition in Peru, that is frontism, they do not fight resolutely against the bourgeoisie.'**<sup>11</sup>

And can it be a Marxist-Leninist-Maoist, Gonzalo thought who writes as the author of this 'statement'? Chairman Mao and Chairman Gonzalo have clearly stated that **'to lead a great revolutionary movement a political party endowed with a revolutionary theory, a knowledge of history and a deep understanding of the practical movement is needed [...]** Marxist theory, Marxism-Leninism-Maoism, national history from a Marxist point of view, mainly that of the last 100 years [...] the most recent, that is key, the previous serves as background. Then he tells us,



**the problem of deep understanding of the practical movement, for what? To see characteristics, laws and how to manage the movement, one who does not do that, who does not study these three problems seriously and carefully, is not a Marxist**".<sup>12</sup> Hence the only answer to the introductory question of this paragraph is: No, the authors of such a 'statement' cannot be Marxists in any sense.

## **6. A NEW UPSURGE OF THE PEOPLE'S MOVEMENT IS TAKING PLACE WHICH NECESSARILY LEADS THE MASSES TO CLAMOR FOR THE MAIN FORM OF STRUGGLE**

For us, applying Gonzalo thought and seeing in the present situation how the laws of the democratic revolution and the people's war are expressed and the present relation between the people's war and the mass movement, starting from the principle that the masses make history. What is happening in the country is the development of the revolutionary situation with a new upsurge of the people's struggle on the basis of the crisis of bureaucratic capitalism and its sweeping away by the people's war that is taking place according to the law established by Chairman Gonzalo at the end of the 1970s:

**'The crisis rages over the people and a growing tendency to people's protest is developing, that rise of the people's movement is the rise of the peasant movement, in essence, and it is this which will develop into armed struggle.'**<sup>13</sup>

This is a law of the class struggle in our country and in all backward countries, thus the greatest development of the revolutionary situation is specific. In the 1960s there was this rise which led to the armed struggle of the Movement of the Revolutionary Left, etc. In the 1980s, on the basis of this crisis, with the initiation of the armed struggle, the Party developed the struggle of the masses, mainly the peasants, and initiated the people's war by its own action with people's initiative. With this began the third moment of contemporary Peruvian society, with the general crisis and demolition of bureaucratic capitalism as well as that of the old State. That is why it is now necessary to specify in what situation the people's war finds itself. That is why we must insist on this by blowing up this reactionary monstrosity.

For this reason, returning to the quotation where the purposes of this 'statement' by the agents of reaction are condensed, we want to emphasize

that it does not say that it leads the people's war but *'the revolution'*, as if any revolution could be led without a people's war and so that there can be no doubt, it links *'revolution'* directly to *'days of struggle'*, that is to say to the struggle for the daily demands of the masses. And, further down, separated without establishing any relation to tailism, he refers to the fact that they are *'advancing in resolving the bend in the road'* of the *'people's war'*. When from the beginning they are separating *'days of struggle'* of the masses from the people's war, that is to say, they pretend to lead *'revolution'* with peaceful struggle. It is a reactionary repetition of the same thing that the Right-opportunist line of the *'peace letters'* says. In all the rest of the *'statement'* there is nothing concrete about the further development of the revolutionary situation and its specification (just like the Right-opportunist line, they deny it — compare their statement on this point); nothing about the situation of the people's war and the three instruments of the revolution except some references that do not correspond, as we have already denounced in all the preceding part of our present document. Even though they mention *'linking the struggle for daily demands with the conquest of power'* twice, this link does not appear anywhere in their *'statement'*.

Thus, they speak of *'revolution'*, *'people's war'*, *'more hunger'*, *'crisis'*, and *'struggle'* repeatedly, that *'bureaucratic capitalism allows the development and advance of the revolutionary process'* (such stupidity, what Gonzalo thought says and emphasizes is that it ripens the conditions for the revolution, to make the people's war; it refers to the objective conditions, that is to say that against its will it generates its gravediggers; but that of *'allowing'* has to do with the subjective), etc., but it does not link, it does not draw synthesis, that is to say the law that corresponds to specify in the present situation of development of the revolutionary situation and of the new rise of the people's movement, in essence of the peasant movement, which leads these to clamor to lead and organize them to develop the people's war. But these reactionary agents in their whole text do not even mention whether or not there is a revolutionary situation developing; the Right-opportunist line in its other text, from which they have copied a large part, does not even mention it when it refers to the international situation, of course when it refers to the situation of the class struggle in the country they do not do so either, pure coincidence? If you doubt, make the comparison, we refer to the proof.

## 7. WHAT DOES THIS MEAN FOR US?

For communists the development of such a revolutionary situation is key and indispensable to lead the people's war, to determine that the current development of the class struggle in the country necessarily leads these classes to clamor for their incorporation into the people's war. What does this mean for us? That today, as yesterday, it is not only a question of mass struggle or '*days of struggle*' of workers, peasants and students, but that what is taking place before our eyes is the rise of the struggle of the peasant masses which necessarily leads them to their incorporation into the main form of struggle, the people's war. Because we already have a people's war — which has reached the strategic stalemate and that being already in that stage it entered the bend in the road with the arrest of Chairman Gonzalo, and then, due mainly to the action of revisionism and opportunism which blew up the Party, it entered this bend in the road, this historical zigzag in which we are — now what we have to do is to use these magnificent conditions that are presented to us of the development of the class struggle which necessarily leads the masses mainly peasants to the main form of struggle which serves the people's war to overcome their present situation. Thus to use these new forces to develop the new tasks that this new rise poses to us and with it to develop the three instruments of the revolution starting from the general reorganization of the Party in a fight to the death against revisionism. Then it does not correspond to our position to develop the '*days of struggle*' or the mass movement without this serving directly and indirectly the people's war, starting with the pending task. That according to what is established today implies developing the actions of the people's war, having the countryside as the main theater, but developing at the same time the actions in the cities, even more so now that the struggle is increasing in them.

That is why Chairman Gonzalo specifies:

**'Another question is that our energies should not be unraveled or centered on this as the main thing, because between daily demands and people's war, the main thing is people's war, daily demands are means, an instrument for, which implies that if I am fighting and resisting at a given moment for daily demands, precisely there I support it with people's war, which is what gives strength to the confrontations. And he adds: there are new tasks and new forces are presented to me**

**[...] thus we will have more contingents that will be forged for higher tasks and we ourselves will direct both.”<sup>14</sup>**

Then, when those of the ‘statement’ do not mention the developing revolutionary situation, they shamefully deny it, and focus on saying that they ‘*struggle inseparably with the masses*’ without showing how these struggles are linked directly and indirectly with the people’s war, they are trying to counterpose these struggles to the people’s war, and who does that is reaction and its lackey revisionism, that is to promote pure frontism, to make the masses tail factions of the big bourgeoisie or their revisionist and opportunist lackeys. What is the interest of the ‘statement’ here? It aims at unraveling us so that we do not fulfill the task of the general reorganization of the Communist Party of Peru, linking the struggle of the masses to the people’s war, that these struggles are not supported with actions of the people’s war, taking from this task of daily demands the new forces to concretize it. Therein lies the crux of the matter of all this grossly reactionary statement. Which is complemented with the other idea that is behind separating war from the mass movement; what it tries to sow, to encourage in our ranks is the counterrevolutionary idea that violence is dangerous, that we should not directly raise the need to develop the people’s war because the masses will be frightened, because otherwise the ‘boogeyman’ comes, genocide; that is why, repeating the rat José of the VRAEM, they said in their ‘directives’ that there should be no banners, no graffiti, no actions, etc. in the cities.

But concretely, what is being seen in the country is that the masses struggle as always and that due to the problems in the Party, these struggles do not have a proletarian leadership and centralization that links them directly and indirectly with the people’s war, that is the other part of the reality. That is why in these struggles revisionism and opportunism reign and that leads these lackeys to divert the struggle of the masses to serve in their reactionary struggle. Concretely we see that in all the struggles taking place in the country revisionism and opportunism are trafficking with the struggle of the masses to defend their positions and privileges as local and regional authorities as part of the old State in contention with the present government and with their sights set on being the government in the 2016 elections. In the concrete case of the anti-Conga front in Cajamarca there is *Red Fatherland* with Gregorio Santos and his peasant patrols and the priest Arana, in Espinar others similar as in Tacna, with their slogans in defense of water and

against dispossession. But if they offer to solve the water problem, even if it is only on paper, for them everything has already been solved, because that will give them electoral results, besides the other arrangements underneath, because ‘the dialogue’, the commitments are not made before the assemblies of the masses, but behind closed doors, even if they put together a whole set-up; thus these regional governments serve as a buffer for the struggle of the masses in favor of the regime, of the Executive, that is one of the functions of the regional governments, while they represent the interests of their own fiefdoms, which in turn are divided into local fiefdoms, etc.

## **8. FOR THE MONSTROSITY IT IS A MATTER OF ‘CONTINUING TO MOBILIZE’ BEHIND THE REACTIONARY AND REVISIONIST FACTIONS AND GROUPS**

Concretely, what is this ‘statement’ calling for? To ‘continue mobilizing’ behind the reactionary and revisionist factions and groups confronted with the government, as in the case of Cajamarca for example, where they ride on the masses to unite them, with the pretext of the ‘defense of water’, to the provisions of the regional government of Gregorio Santos, of the regional government against the provisions of the Executive, of the government of Humala. In this way the masses are led into a reactionary struggle to later collude among themselves. They are not for the struggle of the peasantry for the land, that is to say against the semi-feudalism inseparable from the struggle against bureaucratic capitalism and imperialism, they are not for the struggle with independence and self-determination, they are not for the people’s war to carry the democratic revolution to the end.

And this reactionary agent is so stupid, that he went too far and put: *‘The teachers on June 13<sup>th</sup> [...] showing greater organization and struggle against revisionism in their ranks.’* But everything is known about what these ‘days of struggle’ are, they are those regional strikes advocated by SUTEP and MOVAREF to drain the teachers’ struggle and oppose the general strike, which is the correct thing to do, which has to be done by unmasking the betrayal of the teachers’ struggle by the SUTEP CEN usurped by *Red Fatherland* and the CONARE led by the Right-opportunist line and its electoral monstrosity, the MOVAREF, has to be done by going over their black heads. The directorship that usurped CONARE has promoted these strikes, headed by Condori and other members of MOVAREF, to use this struggle

to propagate their ‘amnesty’ and to collect signatures for their registration as a party in the National Office of Electoral Processes. So these ‘days’ that this communiqué propagates as their own serve the government and the old State, the revisionism of *Red Fatherland* and the MOVAREDEF in their collusion and contention to oppose the general strike of the class-conscious teachers. And these days the traitor leaders of the SUTEP are saying that it is not necessary to go on strike but to make claims before the legal instances through famous lawyers, etc. (See for example the declarations of a leader of the SUTEP of Huaraz on the web page of the newspaper *Huaraz Noticias* of August 17<sup>th</sup> of this year.)

The reactionary agents who have fabricated this monstrosity, pretending to be the directorship of the revolution, are not in conditions and it is not convenient for them to be concrete, to focus on what is under debate in the present situation of the Party and of the country, taking the world situation as a framework. This is in the real, objective situation of the class struggle in the country, that is to say in what period we find ourselves to correctly lead the people’s war, because the leadership of the revolution is embodied in the people’s war led by the Communist Party of Peru, that these miserable reactionaries do not come to try to deceive us by saying that *‘they are leading our revolution in Peru, preparing and developing the days of struggle with the proletariat, peasantry and students throughout the length and breadth of the country’*. And then separately they say that *‘they are advancing in resolving the bend in the road of our vigorous and ardent people’s war [...]’*, when they do not even agree that there is a revolutionary situation. Why do they do it now and not like before when they presented their list of actions? Because we have unmasked them and to simulate what they are not, they can no longer continue saying now, as they did until June, 2011, that they were leading the actions of the people’s war in the country, because they cannot present any action as theirs, because they will never be able to present what their plan in progress is, with its objectives, its foundation, the strategic specifications and the tactics, from the balance of the previous plan, the current advance, etc. That is why they say *‘leading the revolution’* *‘preparing the days of struggle’*, because they believe that in this they can lie, according to them there would be no way of discovering them, but in doing so they have been exposed, they have taken off their mask.

It is up to us to denounce and liquidate this reactionary spawn and crush revisionism and opportunism inside and outside our apparatuses, to reaffirm ourselves in revolutionary violence, in the people's war as the main form of struggle and that the army (the People's Liberation Army) is the main form of organization. It is up to us to see thus the problem of the masses, demands and people's war and as the axis of everything the general reorganization of the Party, of the heroic warrior leading the people's war all-encompassingly to carry the democratic revolution to the end and continue it as a socialist revolution.

## **9. THE WORK OF THE PERU PEOPLE'S MOVEMENT TO CRUSH THIS REACTIONARY HOAX SERVES THE GENERAL REORGANIZATION OF THE PARTY, THE PEOPLE'S WAR AND THE INTERNATIONAL COMMUNIST MOVEMENT**

From all that has been said so far, let us draw an important conclusion for international work, about our organization generated for the Party work abroad, the Peru People's Movement, which has a Marxist-Leninist-Maoist, Gonzalo thought, mainly Gonzalo thought character, which is firmly subjected to our leadership, Chairman Gonzalo, to the basis of Party unity, to the Marxist-Leninist-Maoist, Gonzalo thought Communist Party of Peru and therefore defends its principles, the people's war and the revolution.

The Peru People's Movement can in no case be subject to a non-existing 'Central Committee of the Communist Party of Peru' such as the one issued by the monstrosity in question, irrefutable proof that it is a reactionary organization, here the saying applies: 'Straight from the horse's mouth', and, as it is said, when one confesses, there is no need for proof. It is demonstrated that in every word written by the authors of this 'statement', badly disguised, they distill opposition and class hatred against the principles of the Party and the people's war and against the task of putting Maoism as the only commander and guide of the world revolution, to develop new people's wars in the world, to change the correlation of forces between revolution and counterrevolution on Earth and from the coordination of these communist parties that lead people's war to reunify the communists of the world, in a fight to death against revisionism, in the revived Communist

International, to sweep imperialism and reaction from the face of the earth definitively with people's world war.

We reiterate, our denunciation that after May 1<sup>st</sup>, 2011, after a long process of two-line struggle, we have definitively broken with the reactionary infiltrator agent, who we since our document of April, 2012, have called the native Hu. Therefore, we denounce on this occasion, that this miserable subject continues using the letterhead of the 'Peru People's Movement' and usurping the website and the magazine *Red Sun* and uses them to attack Chairman Gonzalo and Gonzalo thought, the principles of the Party and the people's war, macabrely saying that he is for them, and to infame the revolutionary parties and organizations of the international communist movement and the people's wars, which are developing in hard struggle against revisionism, against the new revisionism that wants to unravel them and lead them to capitulation.

These miserable reactionaries like the Right-opportunist line of the 'peace accords' deny the existence of the communist parties that conduct people's war, to deny the people's war saying that these are revisionist parties or that they have a problem with understanding the new power, as in the concrete case of the Communist Party of India (Maoist), which they accuse of armed revisionism saying that it carries out kidnappings, when these have carried out an action of the people's war and taken prisoners, legitimate action in territory where the new power is exercised or where acts of war are developed by any belligerent army. As in any communist party, there is a permanent two-line struggle until sometimes reaching more acute forms of internal struggle, in a fight to the death between Left and Right, which goes through a process of development that has to do with the development and maturity of the Party itself; these wretches who usurp the name of the 'Peru People's Movement' and the website use the existence of this struggle to launch their epithets of 'revisionists' and oppose any action of the parties to advance in the reunification of the communists of the world, thus fulfilling their service as lackeys of imperialism.

That is why we reject, condemn and crush, also, specifically the reactionary monstrosity when it says: *'It is worth reiterating that the Communist Party of Peru has been struggling to reunite the Revolutionary Internationalist Movement and revolutionary organizations, carrying out international public events through the Peru People's Movement and the Red*



*Sun Magazine that serve to impose Maoism as the commander of the new great wave of the world revolution!"*

So let's quickly see what this 'statement' holds regarding the international situation, everything is copying quotes from academics and other representatives of imperialism, they do not use them according to how we have been taught since Marx, but they repeat everything to substantiate their political line, thus aligning themselves with the imperialist theory of 'geopolitics' and repeat 'geopolitical positioning', *'there is a historical geopolitical change'*. That is to say, pure imperialist and reactionary ideology and politics, thus spreading what world reaction says against what Marxism has established about the class struggle and that war is the continuation of politics by other means. They speak of financial crisis, etc., repeating the representatives of imperialism, and like those, they do not say in this 'statement' that this is an expression of the profound economic crisis in which imperialism is struggling, or of the real economy as the reactionary authors call production, and therefore it is against Marxism. For this 'statement', this crisis does not express the greatest economic collapse of imperialism at the moment of its general and ultimate crisis, of its sweeping away by the world revolution. They speak of the fact that the last crises have produced the *'greatest concentration of wealth in a few hands'* and then *'that there has been the dissemination of economic power throughout the world'*. So where does that leave us? Apparently, these two contrary reasonings are nonsense. But why do they do it? To spread the supposed benefits of 'globalization', which has not only benefited U.S. imperialism but the whole world, originating the economic growth of all countries, as in the countries of the so-called BRICS (Brazil, Russia, India, China to which South Africa has been added), as Jim O'Neill, the inventor of this acronym BRICs at the end of 2001, maintains in his book *'The Markets of Tomorrow'*. The potential of the BRICS and other growing regions, London, 2011, Goldman Sachs economist). This is what they say and what they deny in the 'statement' by the hoax, we are not blaming them gratuitously. What they seek is therefore to veil the sharp contradictions of imperialism, that is why following their favorite reactionary authors, they defend the revisionist theory of 'super-imperialism' as does the Right-opportunist line, and together with the latter they are in favor of the loss of world hegemony of U.S. imperialism and of the so-called 'bipolar world' and in the 'statement', they maintain: *'U.S.*

*imperialism shows itself incapable of unilaterally imposing its own objectives on the world. The loss of the role of sole gendarme leads to a new division of the world in which the collusion and struggle between imperialist powers is developing with an unprecedented militarization, preparing the division of the world."*

This it tries to deny without any basis whatsoever, only following the imperialist propaganda of its academics and other representatives. They pretend to deny that U.S. imperialism is the only hegemonic superpower and world counterrevolutionary gendarme; that as such, everything it does is to maintain that hegemony, that is to maintain and expand in its favor the current world order against all the other imperialists; and that as world policeman — and not *'the only one'* as the authors of the reactionary monstrosity say — it leads the world counterrevolution in its capacity as hegemonic, it intervenes throughout the world against the revolution.

They and the Right-opportunist line want to blind us to U.S. imperialism as the main enemy of the peoples of the world, worse if we are in Latin America, with this they are denying that it intervenes everywhere against the revolution, sometimes directly and sometimes indirectly, according to the advance of the revolution. And that therefore he does not do so in Peru either. With this black line they say that *'their Peru People's Movement'* is serving to impose Maoism, they are shameless phonies.

As in the Right-opportunist line statement cited above, they are supporters of the theory of *'bipolarity'* and loss of U.S. hegemony, which for the Right-opportunist line is between the USA, on the one hand, and China, on the other. While for these phonies it would be between U.S. imperialism, on the one hand, and China-Russia, on the other.

But what is the situation? Although Russia has had a certain recovery in the present decade, based on its natural resources and maintains its parity as atomic superpower with U.S. imperialism, it is not in a position to dispute the hegemony of the latter in all the oceans, continents, etc., as it did in the times when it was social-imperialist. Russia is losing more and more of its industrial capacity every day and is more dependent on the export of oil and gas. The whole military offensive unleashed by U.S. imperialism in the last 20 years shows how it imposes its hegemony and struggles to maintain it, how it advances in its encirclement against Russia and how they are fighting for atomic supremacy with the *'anti-missile shield'*. This does not

imply that the U.S. imperialists are alone and that if they raise their hand the whole world starts to tremble, no, that is revisionism a la Khrushchev. Of course there is a struggle of the other imperialists to also become superpowers and to wrest the hegemony from U.S. imperialism, there are imperialist powers which in the midst of the general collapse, of the ultimate crisis and sweeping away, advance in their purposes. This is reflected in the consciousness of the representatives of imperialism, as for example when one of them says: *'we see every growth of the possibility of power of others as a threat to our hegemony'* (Chas Freeman, former U.S. diplomat, in *Blätter für deutsche und internationale Politik*, No. 4, 2012, p. 50). That is why the siege against the atomic superpower Russia is getting tighter and tighter.

And with respect to social-imperialist China, first it has an export economy too dependent on the US market and based mainly on the 'maquila industry', on the surrender of the labor force of the Chinese proletariat to the voracity of imperialist finance capital and with the surpluses it obtains from its exports it buys U.S. debt bonds (of the Federal Reserve); by focusing on exports, its case is similar to the case of Russia; this fact determines that its economic growth is distorted, i.e. it is not oriented to internal development. In other words, transitory florescence and serious problems that are already occurring with the further deepening of the world economic crisis. China is not yet in a position to dispute the political and military hegemony of U.S. imperialism in all oceans and continents. That is why in the other continents it applies a diplomacy that presents it as 'soft power'. For example, they are just starting their space race, 60 years behind the USA and Russia.

And something else, about the economy and hegemony of U.S. imperialism, as the currency dealer O'Neill says, but here he gets it right: *'The development of the U.S. dollar in relation to other major currencies reflects the fact that productivity in the United States is still higher than in the other major nations. From there the United States draws the capital needed to balance its deficit trade balance.'* That was published in 2011 and is confirmed by recent news reports that the cost of interest on U.S. government debt bonds has been steadily declining from 4% at the beginning of 2011 to 1.6% in July of this year. The *Wall Street Journal* comments on August 13<sup>th</sup>, 2012: *'Investors pay to keep their currency safe'*; *'If you need to flee from one country to a safe country, the U.S. is the best of the bad'* (i.e., they have

no other choice, the floor is sinking everywhere); that is why *'in the face of turmoil in Greece, Spain or Italy many investors are running to the safe arms of the U.S. government'*.

But what is really happening with regard to the collusion and contention between U.S. imperialism and Chinese social-imperialism?

What is happening is that China is beginning to change the military situation in the region starting with the 'South-China Sea'; On the one hand, they are increasing their military presence around China, but this cannot go any further because it would lead them to a direct confrontation, and the time has not yet come for that, that is why we have seen how steps have been taken in application of the strategy established for the region since the Nixon era ('Guam Doctrine'), Obama and Clinton's trips to Pakistan, India, Japan, South Korea and other ASEAN member countries, while moving closer to Australia, are clear evidence of how the U.S. imperialists want to maintain the status quo in Asia and contain China. Despite the problems and major crisis that U.S. imperialism is going through, it has not been displaced as the sole hegemonic superpower and world counterrevolutionary gendarme, but see how from failure to failure they continue to develop their plan to exercise and maintain hegemony. For example, Brzezinski, former U.S. National Security Advisor from 1977 to 1981, calls this strategy: *'Balancing the East and Expanding the West. America's grand strategy in an era of upheaval'*, which is also the title of his latest book, when he refers to *'expanding the West'* he is thinking that Europe should include Russia, of how, presumably by applying similar forms of intervention as we are currently seeing, but applied to the specific conditions in Russia and as to the former he says: *'The role of the United States in Asia should be to seek regional balance, replicating the role played by the United Kingdom in intra-European politics during the 19<sup>th</sup> and early 20<sup>th</sup> century. The United States can and should help Asian countries avoid a struggle for regional dominance by mediating conflicts and neutralizing power imbalances between potential rivals.'* (in: *Foreign Affairs Latin America*, V. 12 No. 2 2012, 93).

That talk of 'unipolar', 'bipolar' world or unilateralism, multilateralism, etc., that wants to make us believe that imperialism is one has only one pole or different parts, if there is not only one pole that makes the decisions of the world government, this is more democratic, that is the background of this, as we said to veil the deep contradictions of imperialism, its

monopolist, parasitic and decomposing character, which is sinking in the middle of immense genocides that it unleashes all over the world, wars of all kinds; These are therefore terms invented by imperialist diplomacy which wants us to believe in a world governance, in which the United Nations, NATO, the IMF, the World Bank, etc. But we cannot repeat this story that tries to hide the fact that these institutions are instruments of U.S. imperialism, established together with the predominance of the dollar, as a consequence of the 2<sup>nd</sup> World War from which it emerged as the hegemonic imperialist superpower. These international institutions are instruments used by the USA in the exercise of its hegemony in collusion and struggle with the other imperialist powers. When some of the other five permanent members of the UN Security Council veto a U.S. proposal, they will in any case seek to apply their plan, their aggression or whatever, using other means, that is, leaving aside their own instrument, as we are seeing at the moment with the situation in Syria and Iran and with the same application of the anti-missile shield plan which they are complementing with some variations, they have already extended it to the Middle East and with this they are covering a wider area. In other words, as another representative of U.S. imperialism points out, this game of unilateralism or multilateralism or whatever you want to call it, is produced in these institutions when U.S. imperialism does not use its ‘leadership’. That is what the electoral campaign of the genocidal Obama is being accused of by his Republican rivals. In other words, it is a question of which is better for imperialism, the ‘carrot or the stick’. It is therefore a question of domestic policy on the one hand and of how to apply their plans according to how the situation is going for them. But they, like all other imperialists, are at the moment of their collapse and always march from failure to failure until their final collapse, that is the law of imperialism established by Chairman Mao.

But these phonies of the ‘statement’ are so cynical that they dare to maintain that: *‘It is necessary to form a great anti-imperialist movement, firmly striving to be guided by Marxism-Leninism-Maoism, mainly Maoism [...]’* About ‘their’ Marxism, people’s war and everything else that these wretches say in the quote to cover up their true purposes, we have already denounced it, for the moment we believe it is enough, we refer to our previous paragraphs in this regard. But it is worth saying something about *‘forming a great anti-imperialist movement’*. On this, to begin with, that they are

not anti-imperialists but rather embellishers of U.S. imperialism and servants of its counterrevolutionary world role of world police or gendarme. But the national liberation movement will not be formed neither by these wretches nor by any other upstart, it already exists, it is a reality of this era of the proletarian world revolution in which we are developing, it is one of the currents of the international communist movement, the question is to put Maoism as its only commander and guide, developing people's war led by the communist parties. The international line of the Communist Party of Peru has stated:

**‘There are two currents that operate in the international communist movement: The international proletarian movement and the national liberation movement. The first leads and the second is the base.**

**The national liberation movement. It is waged in the oppressed nations against imperialism and reaction. [...] Lenin [...] concluded that revolution was shifting to the oppressed nations, but this fact does not negate the revolution in Europe [...] Lenin laid the foundations of the strategy for world revolution to undermine imperialism, link the struggle of the national liberation movement with the struggles of the international proletarian movement, and to develop the revolution. If the slogan for communists is ‚Proletarians of all countries, unite!’, he put forth the slogan that should guide the struggle of the two forces: ‚Proletarians of all countries and peoples of the world, unite!’ Chairman Mao Tse-tung developed Lenin’s strategy centering on the transcendental importance the national liberation movement has for the world revolution since imperialism robs more and more from the oppressed nations, which in turn rise up in powerful revolutionary storms that should be led by their communist parties. Thus, the national liberation movement is grounded on the international proletarian movement and these two forces propel the development of world history. Chairman Gonzalo teaches us that the strategy that we communists must unfold should start from the foundations laid down by Lenin and developed by Chairman Mao.’<sup>15</sup>**

And then they will say as cynical and crafty as they are: *‘Striving to reunite the Revolutionary Internationalist Movement and revolutionary organizations, carrying out international public events through the Peru People’s Movement and the Red Sun Magazine that serve to impose Maoism as*

*commander of the new great wave of the world revolution! Particularly seeing the fundamental aspect of Maoism which is power, we consider that at this point is where some communist parties have problems to continue the development of the people's war in their countries. The current international situation allows for a bold advance by the communists."*

The representatives of the parties and organizations inside and outside of the Revolutionary Internationalist Movement know directly who this guy is and his bastard accomplices, the only thing they do is to attack left and right the parties and organizations of the international communist movement and try to sabotage the international campaign for the people's war in India and thus all the coordination efforts of the Maoists at the international level, for those some of the representatives of the parties say: *'they only look like traffickers'*. Yes, even their very appearance is of counterrevolutionary traffickers, this subject since he appeared in these parts all his work has been directed not only to liquidate the Peru People's Movement but to serve the liquidation of the Revolutionary Internationalist Movement and to isolate the Communist Party of Peru from the parties and organizations of the international communist movement, but he has only succeeded in isolating himself, and this done consciously because he cannot answer any question posed to him about the real situation of the Party and the people's war. The parties and organizations know that a representative of the Communist Party of Peru to speak with them has to give a report that follows the guidelines that Chairman Gonzalo himself has consigned in all the published Party documents. Not like those which claim to contain these 'directives' or 'statements' like this one, or lists of actions taken from the reactionary press in the absence of a real Party report on the fulfillment of the plans, campaigns and actions of the people's war.

If a certain or supposed directive or statement, as in this case that we are criticizing, is opposed to the principles of the Party and the people's war, we have to reject it, to mark it and fire it and blow it into a thousand pieces, Chairman Mao teaches us that to rebel against reactionaries is justified and necessary. Against this, what the agents of imperialism have done in the ranks of the communist parties, that is to say the revisionists and their infiltrated agents, is to resort to Party discipline to isolate the Left to then try to liquidate it; this way of trying to counterpose Party discipline with the philosophy of struggle, the principle of going against the current, a

contradiction that in no way is antagonistic while the directorship adheres to the position, method and world outlook of the proletariat, becomes antagonistic when there is a change of directorship. To draw a lesson with the negative example of what happened with these ‘directives’, ‘statements’ and supposed ‘representatives of the Party’ and the ‘Central Committee’, in reality agents of reaction that have substituted the true Party connection. It is a bitter lesson from which not only Peru People’s Movement members, but all communists and revolutionaries of the world must learn a negative lesson.

**10. CELEBRATE THE 20<sup>TH</sup> ANNIVERSARY OF CHAIRMAN GONZALO’S SPEECH WHICH SHINES VICTORIOUSLY AND POWERFULLY BEFORE THE WORLD AS A COMBAT WEAPON!**
